

ORDINANCE NO. 2227

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO ARTERIAL STREETS FOR THE CITY OF KIRKLAND, ADOPTING THE REVISED SIX YEAR PROJECT PROGRAM FOR STREET IMPROVEMENT, THE SIX YEAR ARTERIAL IMPROVEMENT, AND THE SIX YEAR URBAN ARTERIAL PROGRAM, AND AMENDING CHAPTER 19.8, ARTERIAL STREETS, OF THE KIRKLAND MUNICIPAL CODE, SECTIONS 19.08.010 THROUGH 19.08.060, INCLUSIVE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 19.08.010 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.010 Major Arterial Streets. The following streets of the City are hereby designated Major Arterial Streets:

Section 5. Section 19.08.050 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.050 Six Year Arterial, Urban, Arterial and Neighborhood Collector Street Improvement Programs Adopted.

Pursuant to RCW Chapter 35.77, the following six year street improvement plans are updated, revised and adopted as set forth in the exhibits attached to this ordinance, which by this reference are incorporated herein:

- Exhibit A - The Six Year Arterial Street Program
- Exhibit B - The Six Year Urban Arterial Street Program
- Exhibit C - The Six Year Neighborhood Collector Street Program.

A copy of each of said street improvement programs, including Exhibits A, B & C, together with a copy of this ordinance, shall be filed with the Director of State Highways for the State of Washington as required by law.

"As provided in Ordinance No. 2093 adopting the circulation element of the comprehensive plan, the arterial street program herein adopted and approved is in conformance to and in furtherance of said circulation element.

Section 6. Section 19.08.060 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.060 Street Lighting and Traffic Control.
All arterial streets shall be provided with adequate



street lighting for safer traffic control. Traffic control lights shall be installed at intersections as determined by traffic studies."

Section 7. This ordinance shall be in force and take effect five days from and after its passage by the Council and publication as required by law.

Six Year Comprehensive Street Program

1. The Proposed Action

State Statute RCW 36.81.121 and RCW 37.77.010 requires that the Kirkland City Council, pursuant to a public hearing, shall prepare and adopt a comprehensive street program for the ensuing six calendar years and shall file the same with the Director of Highways not more than thirty days after its adoption. Two copies of the program should be submitted to the Washington State Highway Commission, 10506 N.E. 4th St., Bellevue, Washington 98004, Attention: Huntly W. Grant, District State Aid Engineer prior to July 31, 1973.

2. Existing Conditions

The original ordinance was prepared prior to July 1, 1968 and has been updated annually since that time.

3. Environmental Impact of the Proposed Action

There are no changes in this proposed ordinance as it relates to the previous ordinance except that Exhibits A, B, and C estimated costs have been updated to reflect the current construction costs.

4. Any Unavoidable Adverse Environmental Effects

There should be no unavoidable adverse environmental effects as the street programs are on the decline and it is not anticipated that any of the projects will be funded in the coming year. If funding should be obtained then that particular project will be required to prepare an individual assessment.

5. Alternates to the Proposed Action

There are no known alternates to the plan except a do nothing program.

6. Relationship between local short-term environmental uses and the maintenance enhancement of long-term productivity.
