ORDINANCE NO. 2279

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO THE KIRKLAND WATER-SEWER SYSTEM, ADJUSTING CERTAIN RATES FOR WATER AND SEWER SERVICE AND AMENDING CHAPTER 15.24 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

The following sections of Chapter 15.24 of the Kirkland Municipal Code relating to monthly service and consumption rates for water and sewer service are each hereby amended to read as follows:

Section 15.24.020 Basic Water Rate - Residential. Basic residential water rates are as follows:

(1) Single family residence - \$4.00 per month;

(2) Multi-family residence, including duplexes -[\$2,00] \$2.50 per month per unit or apartment;

(3) The single family basic monthly rate shall include

[four] two hundred cubic feet of water consumed;

(4) The basic rate shall be charged whether the premises are occupied or vacant. (Ord. 2129 Sec. 1(part), 1970: Ord. 2062 Sec. 6.01, 1969)

Section 15.24.030 Basic water rate-Nonresidential. Basic non-residential water rates (including commercial establishments, manufacturing establishments, schools and churches) shall be as follows:

Section 15.24.040 Water consumption charge. In addition to the basic monthly rate, the charge for water consumed during the billing period (bi-monthly) shall be:

- [41)--Fer-the-first-five-thousand-eubic-feet-ef-water consumed--Twenty-five-cents-per-one-hundred-cubic-feet;
- (2)--0ver-five-thousand-aubic-feet-of-water-consumed+ twenty-two-cents-per-one-hundred-cubic-feet+]
- (1) For residential customers: forty cents per one hundred cubic feet of water consumed;

(2) For non-residential customers: Forty-five cents

per one hundred cubic feet of water consumed;

(3) Where the basic rate includes some water consumption (single family residential customers) the consumption rate shall be calculated on water consumed in excess of the amount included in the basic rate. (Ord. 2129 Sec. 1(part), 1970: Ord. 2062 Sec. 6.03, 1969)

Section 15.24.070 Monthly sewer rates. The monthly sewer charge required to be paid to the city by customers of the sewer system is established as follows:

(1) Single family residence: [Six-dellars-and-twenty-

five-eents;] Seven Dollars eighty cents;

(2) Multi-family residence, including duplex: One Dollar fifty cents per month per unit or apartment, plus [seventy-cents] ninety cents per one hundred cubic feet of water consumed;

- (3) School buildings: Thirty cents per student. Student enrollment shall be determined at the beginning of the school year, and adjusted at the beginning of the second semester. The rate for the months of June, July and August shall be eleven dollars per month, provided, however, that school buildings used for summer school shall pay the per student rate on actual count of full-time students, and one-half the student rate for part-time students in attendance at summer school. The foregoing rates for school buildings shall not apply to those school buildings where an exempt meter has been installed;
- (4) All other sewer customers (including school buildings where an exempt meter has been installed): [Seventy]Ninety cents per one hundred cubic feet of water consumed, provided, however, that the monthly rate per customer or establishment shall not be less than [six-dellars-and-sixty-cents-] Seven Dollars eighty cents.(Ord. 2129 Sec. 1(part), 1970: Ord. 2124 Sec. 1, 1970: Ord. 2098 Sec. 1, 1970: Ord. 2062 Sec. 6.06, 1969).

Section 2. The rate adjustments herein provided shall become effective as to each customer as of the first day of December _____, 1974.

Section 3. This Ordinance shall be in force and take effect five days from and after its passage and publication as required by law.
