

ORDINANCE NO. 2287

AN ORDINANCE OF THE CITY OF KIRKLAND ANNEXING, PURSUANT TO RCW 35A.14.295 ET SEQ. AN UNINCORPORATED TERRITORY CONSISTING OF THREE ISLANDS WITHIN THE CITY OF KIRKLAND AS HEREIN DESCRIBED, PROVIDING FOR THE ASSUMPTION OF EXISTING INDEBTEDNESS, AND ZONING SAID TERRITORY IN ACCORDANCE WITH ORDINANCE NO. 2183, THE KIRKLAND ZONING ORDINANCE, NOW IN EFFECT WITHIN THE HOUGHTON COMMUNITY.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. In accordance with RCW 35A.14.295 et seq., hearing having heretofore been held as required on the 18th day of February, 1975, the hereinafter described unincorporated territory consisting of three islands of unincorporated area totaling less than 100 acres in size and having at least 80% of the boundaries thereof contiguous to the City of Kirkland, is hereby annexed to the City of Kirkland.

Section 2. Said territory shall be subject to the existing indebtedness of the City of Kirkland as of the effective date of this annexation ordinance.

Section 3. Said territory shall be zoned in accordance with Ordinance No. 2183, the Kirkland Zoning Ordinance and each of the hereinafter described areas shall be within the land use classification designated on the maps which are a part of said Zoning Ordinance. If any of said areas are not so designated on the zoning map, then such areas shall be within the land use classification abutting said area and if more than one land use classification so abuts, then the land use classification which provides for the least density.

Section 4. The areas annexed to the City of Kirkland by this Ordinance are described as follows:

Parcel 1: Shorelands westerly of Gov't Meander Line in SW 1/4, Section 17, Township 25 North, Range 5 EWM, sly. pt. at MDR corner on N. line of Section 20; thence west 30 ft; thence N. $37^{\circ}27'44''$ W. 1134.65 feet, more or less to shoreline; thence along new ARL shoreline to intersect with Gov't Meander Line.

beginning; thence continue on westerly section
line N $0^{\circ}32'57''$ W. 1701 feet plus or minus to a
point intersecting with south right-of-way line of
N.E. 47th St. extended; thence 30 feet N. $89^{\circ}09'29''$
East on said right-of-way line extension; thence
S $0^{\circ}32'57''$ E. 638.35 feet; thence N. $89^{\circ}08'30''$ E.
300.33 feet; thence S $0^{\circ}32'57''$ E 30 feet; thence
N. $89^{\circ}08'30''$ E. 355.35 feet; thence S $53^{\circ}29'50''$

of-way thence S. $77^{\circ}04'30''$ W. 30 feet; thence continue on
right-of-way boundary line N. $12^{\circ}55'30''$ W. 64 feet
plus or minus to intersection with pipe line right-of-
way; thence S. $49^{\circ}50'30''$ W. along pipeline right- Ordinance No. 2287
of-way south boundary line 110 feet plus or minus to
point of beginning.

Section 5. This Ordinance and annexation shall become effective either on approval of the Houghton Community Council or upon its failure to disapprove within 60 days of the passage of this Ordinance, provided however, that pursuant to RCW 35A.14.299, the effective date shall not be sooner than 45 days after the date of passage of this Ordinance by the City Council.
