

ORDINANCE O-4667

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING THE AMOUNT OF PROPERTY TAXES TO BE LEVIED FOR THE YEAR 2019, THE FIRST YEAR OF THE CITY OF KIRKLAND'S 2019-2020 FISCAL BIENNIUM.

1 WHEREAS, the City Council held a public hearing on September  
2 18, 2018, to consider revenue sources for the 2019-2020 Biennial  
3 Budget; and

4  
5 WHEREAS, the City Council and the City Manager have considered  
6 the anticipated financial requirements of the City of Kirkland for the  
7 fiscal year 2019; and

8  
9 WHEREAS, pursuant to RCW 35A.33.135, the City Council is  
10 required to determine and fix by ordinance the amount to be raised by  
11 ad valorem taxes; and

12  
13 WHEREAS, RCW 84.55.120 requires that the increase in the levy  
14 over the prior year be stated both as to the dollar increase and  
15 percentage change.

16  
17 NOW, THEREFORE, the City Council of the City of Kirkland do  
18 ordain as follows:

19  
20 Section 1. The regular property tax levy for the year 2019 is  
21 hereby fixed and established in the amount of \$31,637,515. This  
22 property tax levy represents a dollar increase of \$291,524 and a  
23 percentage increase of one percent from the previous year, excluding  
24 the addition of new construction, improvements to property, any  
25 increase in state-assessed property, and administrative refunds as  
26 shown below:

27 Section 2. There is hereby levied for 2019 upon all property,  
28 both real and personal, within the City of Kirkland, Washington, and  
29 within the area subject to tax levies for the principal and interest of all  
30 general obligation bond issues, a total voted property tax of \$564,105  
31 on the total of assessed valuation for such property.

32            Section 3. This ordinance shall be in force and effect five days  
33 from and after its passage by the Kirkland City Council and publication  
34 pursuant to Section 1.08.017, Kirkland Municipal Code in the summary  
35 form attached to the original of this ordinance and by this reference  
36 approved by the City Council.

PUBLICATION SUMMARY  
OF ORDINANCE NO. O-4667

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING THE AMOUNT OF PROPERTY TAXES TO BE LEVIED FOR THE YEAR 2019, THE FIRST YEAR OF THE CITY OF KIRKLAND'S 2019-2020 FISCAL BIENNIUM.

SECTION 1. Fixes and establishes the regular property tax levy for the fiscal year 2019.

SECTION 2. Levies a voted property tax for fiscal year 2019.

SECTION 3. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.

The full text of this Ordinance will be mailed without charge to any person upon request made to the City Clerk for the City of Kirkland. The Ordinance was passed by the Kirkland City Council at its meeting on the 20th day of November, 2018.
