

Ordinance No. 2301

AN ORDINANCE LEVYING THE TAXES FOR THE CITY OF KIRKLAND,
WASHINGTON FOR THE YEAR 1976.

Section 1. The tax levy for the City of Kirkland for
property taxes for the year 1976, is hereby fixed and established
as follows:

Regular RCW 84.52.043	\$ 223,346,947.	\$ 3.375	\$ 753,795.96
Firemen Pension RCW 41.16.060	\$ 223,346,947.	.225	50,253.06
Total Reg. Levy	\$223,346,947.	\$ 3.600	\$ 804,049.02

Provided, however, that the total property taxes levied by
the City of Kirkland pursuant to RCW 84.52.043 shall not
exceed: 106% of the amount of regular property taxes levied
by the City of Kirkland in 1975 (Kirkland Ordinance No. 2275),
plus an additional dollar amount calculated by multiplying
the increase in assessed valuation resulting from new const-
ruction and improvements to property within the City of Kirk-
land (including the Totem Lake Annexation area, Kirkland
Ordinance No. 2252) by the 1975 tax levy rate (3.60 per \$1,000
of assessed valuation). Further provided that the total tax
amount shall not exceed \$.0036 times the total assessed
valuation for general tax purposes." (Application of the above
will produce an actual total tax revenue of \$636,146.37).

First Extraordinary Session, 42 Legislature.


Section 2. This Ordinance shall be in force and take effect
