ORDINANCE NO. 2335

AN ORDINANCE ADOPTING BY REFERENCE THE WASHINGTON MODEL TRAFFIC ORDINANCE (RCW CHAPTER 46.90) AND OTHER TRAFFIC STATUTES TO REGULATE TRAFFIC ON THE HIGHWAYS AND WAYS OPEN TO THE PUBLIC IN THE CITY OF KIRKLAND AND REPEALING PORTIONS OF CHAPTER 12 OF THE KIRKLAND MUNICIPAL CODE IN CONFLICT THEREWITH, EXCEPT AS SET FORTH HEREIN AS SPECIFICALLY BEING RETAINED.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. RCW Chapter 46.90 (Washington Model Traffic Ordinance), hereinafter referred to as MTO, is by this reference adopted as part of Chapter 12.60A of the Kirkland Municipal Code, providing that the following sections of RCW Chapter 46.90 are not adopted:

Section 3: Penalties. Any person who is convicted of violating or failing to comply with any provisions of this chapter shall be punished by fine not to exceed \$500.00, except for the offenses listed below which shall be punishable by a fine not to exceed \$500.00, or imprisonment in the Kirkland City Jail for not more than 180 days or both:

RCW 46.20.342 Relating to driving while license suspended or revoked

RCW 46.52.010 Relating to duty on striking unattended car or other property

RCW 46.52.020 Relating to duty in case of injury to or death of person or damage to attended vehicle

RCW 46.61.500 Relating to reckless driving

RCW 46.61.530 Relating to racing of vehicles on highways--Reckless driving

RCW 46.61.535 Relating to advertising of unlawful speed attained--Reckless driving

Section 4: Chapter 12 of the Kirkland Municipal Code, vehicles and traffic, with the exception of those portions which are immediately listed below as retained, are hereby repealed. The following sections shall be retained in full force and effect:

Section 5. There is hereby added to Chapter 12 a new section, subtitled "Inattention."

12.28.020 Inattention. It is unlawful for any person to operate a motor vehicle in an inattentive manner over the highways of this city. For the purpose of this section, "inattentive" means the operations of a vehicle upon the public highways of this city in a lax or slack manner. The offense of operating a motor vehicle in an inattentive manner shall be considered to be a lesser offense than, but included in the offense of operating a vehicle in a negligent manner.

Section 6. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of this ordinance, or the application of the provision to other persons or circumstances shall not be affected.

Section 7. The City shall maintain at all times available for the use of the general public at the City Hall, 210 Main Street, Kirkland, Washington 98033, not less than three (3) copies of the Washington Model Traffic Ordinance, RCW Chapter 46.90, and the sections of the Revised Code of Washington herein adopted by referenced.

land City Council and publication as required by law.
