ORDINANCE NO. 2369

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO MONTHLY SERVICE SEWER RATES FOR SCHOOL BUILDINGS AND AMENDING SECTION 15.24.070 OF THE KIRKLAND MUNICIPAL CODE.

WHEREAS, the City of Kirkland has a long term sewage disposal contract with the Municipality of Metropolitan Seattle, which contract obligates Metro to accept the City's sewage subject to such reasonable rules and regulations as may be adopted from time to time by the Metropolitan Council, and

WHEREAS, the Metro system and therefore, the Kirkland sewer system discharge into public waters, subject to federal water pollution control jurisdiction, and are required to conform to certain federal regulations in relation to the Federal Water Pollution Control Act. and

WHEREAS, pursuant to said regulations, Metro has determined that the provisions of the Kirkland Municipal Code establishing monthly sewer rates for certain school buildings result in a preferential rate in contravention of said federal rules and regulations, which said rules and regulations require that service rates be uniform and equitable and that no user class may subsidize another class.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Kirkland as follows:

 $\frac{\text{Section 1.}}{\text{as follows:}}$ Section 15.24.070 is hereby amended to

"15.24.070 Monthly sewer rates. The monthly sewer charge required to be paid to the city by customers of the sewer system is established as follows:

(1) Single family residence: seven dollars and

eighty cents;

(2) Multi-family residence, including duplex:
One dollar and fifty cents per month per unit or
apartment, plus ninety cents per one hundred cubic
feet of water consumed up to a maximum of seven hundred cubic feet per unit or apartment

[{3},-Sehool-building+-Thirty-cents-per-student-Student-enrollment-shall-be-determined-at-the-beginning of-the-school-year,-and-adjusted-at-the-beginning-of-thesecond-semester--The-rate-for-the-months-of-June,-July and-August-shall-be-eleven-dollars-per-month;-provided; however;-that-school-buildings-used-for-summer-school shall-pay-the-per-student-rate-on-actual-count-of-full--time-students;-and-one-half-the-student-rate-for-part-time-students-in-attendant-at-summer-school;--The-fore-going-rates-for-school-buildings-shall-not-apply-to those-school-buildings-where-an-exempt-meter-has-been installed:

(4) All other sewer customers [{including-school buildings-where-an-exempt-meter-has-been-installed}:]
Ninety cents per one hundred cubic feet of water consumed, provided, however, that the monthly rate per customer or establishment shall be not less than seven dollars and eighty cents."

Section 2. This Ordinance shall take effect and be in force five (5) days from and after its passage and publication in the manner required by law. Provided that the change in monthly sewer service rates shall be effective January 1, 1978.
