AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO MOTOR VEHICLES AND PROHIBITING THE PARKING OF MOTOR VEHICLES ON CERTAIN STREETS AND DURING CERTAIN TIMES AND AMENDING SECTION 12.44.040 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 12.44.040 of the Kirkland Municipal Code is hereby amended as follows:

12.44.040 Parking prohibited on certain streets at certain times. Pursuant to this title and Sections 12.44.050 through 12.44.100, it is hereby declared to be unlawful for any person to park or stand a motor vehicle in the following areas during the hours indicated:

<u>Parking restriction area</u>	<u>Hours parking prohibited</u>
A. <u>No Parking At Any Time</u>	
1. East side of Lake Street between Central Way and Kirkland Avenue	At all times
2. East side of Lake Street South between Kirkland Avenue and a point 125 feet south of the center line of Kirkland Avenue (<u>the alley south of Kirkland Avenue</u>)	At all times
3. <u>South side of Central Way between Lake Street and Sixth Street</u>	At all times
4. <u>South side of Northeast 85th Street between Sixth Street and 120th Avenue Northeast</u>	At all times
5. <u>North side of Northeast 85th Street between 122nd Avenue Northeast and Sixth Street</u>	At all times

B. No parking between the hours of 4 p.m. to 6 p.m. and two-hour limited parking between the hours of 9 a.m. to 4 p.m.

[(3)](6) West side of Lake Street between Commercial [Way] Avenue and Kirkland Avenue 4 p.m. to 6 p.m.

[(4)] (7) East side of Lake Street between a point 125 feet south of the centerline of Kirkland Avenue (alley south of Kirkland Avenue) and a point [~~275-feet south-of-the-centerline-of-Kirkland Avenue~~] 100 feet south of Second Avenue 4 p.m. to 6 p.m.

Section 2. There is hereby added to Chapter 12.44 of the Kirkland Municipal Code, a new section to read as follows:


12.44.045 Authority to impound and tow away. A motor vehicle left standing or parked within any of the parking restricted areas established in Section 12.44.040 during the hours of parking prohibited in such area constitutes an immediate safety hazard to the users of the public right-of-way and the general public. Such vehicle may be impounded and removed from the prohibited parking area under the supervision and authority of any Kirkland Police Officer.

NEW SECTION


Section 3. This ordinance shall be in force and effect five (5) days after its passage and publication as required by law.

PASSED by a majority vote of the Kirkland City Council at a regular meeting on 17th day of April, 1978.


