## ORDINANCE NO. 2387

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO GARBAGE AND REFUSE COLLECTION ESTABLISHING NEW COLLECTION SERVICE RATES AND AMENDING SECTION 16.12.030 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 16.12.030 be and it hereby is amended to read as follows:

"16.12.020 <u>Collection rates - effective date</u>. The rates to be charged for refuse collection service in the City shall be as follows:

## (1) RESIDENTIAL, SINGLE FAMILY:

One pickup per week, everything placed for collection:

- (4) Wherever detachable containers are used having a capacity for which a rate has not been established, the director of administration and finance is authorized to establish a rate for such container which shall be consistent with the ratio of container capacity to rate charge for the rates herein established.
- [(5) Netwithstanding-the-effective-date-of-this-amendatory-ordinance eodified-herein,-the-rates-established-in-this-section-shall become-effective-commencing-August-1,-1973,-or-as-soon-there-after-as-such-change-in-rates-shall-be-permitted-under-the President's-economic-stablization-program."]

Section 2. This ordinance shall be in force and effect five days from and after its passage and publication as required by law, provided, however, that the rates for refuse and garbage collection herein established shall become effective as of June 1, 1978.
