ORDINANCE NO. 2396

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO VEHICLES AND TRAFFIC, SPECIFICALLY OVERTIME PARKING, AMENDING AND ADDING CERTAIN SECTIONS AND SUBSECTIONS OF TITLE 12 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland, as follows:

<u>Section 1.</u> Section 12.44.010(d) of the Kirkland Municipal Code is hereby amended to read as follows:

"12.44.010(d) The authority granted to the Police Department by (Seetien-12-56-010) Sections 12.44.085(2), 12,44.045 and 12.48.040 of this title in respect to the impounding of vehicles shall include any trailer parked in violation of this section."

<u>Section 2.</u> Section 12.44.085 is hereby added to the Kirkland Municipal Code and provides as follows:

"12.44.085 Overtime Parking - Penalties, Impoundment.

- 1. If any vehicle is in violation of Kirkland Municipal Code 12.44.060, 12.44.070 or 12.44.080, the following penalties shall be imposed:
 - A. Five Dollars (\$5.00) for any single violation.
 - B. If more than one (1) violation occurs within any nine (9) hour period, the second, and each successive violation, shall warrant a penalty of Ten Dollars (\$10.00).
- 2. The Kirkland Police Department is hereby authorized to impound any vehicle determined to be in violation pursuant to Kirkland Municipal Code 12.44.060, 12.44.070 and/or 12.44.080 (Zones 1, 2, 3, 4, 5 and 6 only), provided that such violation is the second violation within any nine (9) hour period. This provision is in addition to and an alternative to subsection (1) of this section.
 - A. The procedures set forth in RCW 46.90.330 as adopted by reference through Kirkland Municipal Code 12.60.010, shall apply to any impoundment authorized by this section."

Section 3. Section 12.48.040 is hereby amended to read as follows:

"12.48.040 Authority to Impound. Any vehicle left unattended within a bus stop zone is declared to be an obstruction to traffic

and immediate danger to the safety of the general public and a public nuisance. Such public nuisance shall be summarily abated by the removal and impoundment of such vehicle in accordance with the procedures established for removal and impounding of vehicles set forth in Chapter [$\frac{12.56}{12.60}$] 12.60 of the Kirkland Municipal Code."
