ORDINANCE NO. 2402

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO ARTERIAL STREETS FOR THE CITY OF KIRKLAND, ADOPTING THE 1978 REVISED SIX (6) YEAR PROJECT PROGRAM FOR STREET IMPROVEMENT, INCLUDING THE SIX (6) YEAR ARTERIAL IMPROVEMENT AND THE SIX (6) YEAR URBAN ARTERIAL PROGRAM AND AMENDING SECTION 19.08.050 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 19.08.050 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.050 Six Year Arterial, Urban Arterial and Neighborhood Collector Street Improvement Programs Adopted.
Pursuant to the requirements of RCW Chapter 35.77, the following Six Year Street Improvement Plans are updated, revised and adopted as set forth in the exhibits attached to this ordinance which by this reference are incorporated herein:

Exhibit A - The Six Year Arterial Street Program (1978 Revision)

Exhibit B - The Six Year Urban Arterial Street Program (1978 Revision)

Exhibit C - The Six Year Neighborhood Collector Street Program (1978 Revision)"

A copy of each said Street Improvement Programs including Exhibits A, B and C, together with a copy of this ordinance shall be filed with the Washington State Department of Transportation as required by law.

As provided in Ordinance No. 2346 adopting the Circulation Element of the Comprehensive Land Use Policies Plan, the Arterial Street Program herein adopted and approved is in conformance to and in furtherance of said Circulation Element.

Section 2. This ordinance shall be in force and take effect five (5) days from and after its passage by the Council and publication as required by law.
