

ORDINANCE NO. 2419

AN ORDINANCE AMENDING ORDINANCE NO. 2415 LEVYING TAXES FOR THE CITY OF KIRKLAND, WASHINGTON, FOR THE YEAR 1979 TO CLARIFY THAT THE AMOUNT SO LEVIED IS TO BE EXCLUSIVE OF ANY SUPPLEMENTAL COLLECTIONS OF PRIOR YEARS TAXES DUE AS A RESULT OF THE "BURLINGTON NORTHERN CASE".

BE IT ORDAINED BY THE City Council of the City of Kirkland as follows:

Section 1. The tax levy for the City of Kirkland for property taxes for the year 1979, is hereby fixed and established as follows:

Provided, however, that the total property taxes levied by the City of Kirkland pursuant to RCW 84.52.043 shall not exceed: 106% of the amount of regular property taxes levied by the City of Kirkland in 1976 (Kirkland Ordinance No. 2301), plus an additional dollar amount calculated by multiplying the increase in assessed valuation resulting from new construction and improvements to property within the City of Kirkland by the 1976 tax levy rate (3.60 per \$1,000 of assessed valuation). Further provided that the total tax amount shall not exceed \$.0036 times the total assessed valuation for general tax purposes. (Application of the above will produce an actual total tax revenue of \$875,031.88; and further provided that said total revenue to be raised by taxation as set forth hereinabove is exclusive of any supplemental collections of prior years taxes due as a result of the "Burlington Northern case".


*Special levy reduced by King County Supplemental billing as a result of the "Burlington Northern Case" in the amount of \$6,547.


