

ORDINANCE NO. 2426

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO IN-CITY SEWER INSTALLATION AND CONNECTION FEES AND AMENDING SECTION 15.12.060 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 15.12.060 of the Kirkland Municipal Code is hereby amended to read as follows:

"15.12.060 Sewer Installation fee. Whenever any connection is made for the benefit of property lying within the city limits to the city sewer system, the following installation fees shall be paid:

<u>(1) Basic Fee:</u>	<u>INSIDE CITY</u>
<u>Sewer Permit fee</u>	<u>\$ 25.00</u>
<u>Stub-in fee</u>	<u>\$300.00</u>
<u>Trunkage fee:</u>	
<u>(a) Single family</u>	<u>\$400.00 plus \$.05 per square foot of the total area of the property to be served or benefited by the connection;</u>
<u>(b) Multi-family</u>	<u>\$200.00 per unit plus \$.05 per square foot of the total area of the property to be served or benefited by the connection;</u>
<u>(c) all other uses</u>	<u>\$.10 per square foot of the total area of the property to be served or benefited by the connection.</u>

<u>[{1}] [Basic-Fee+]</u>	<u>[INSIDE-CITY]</u>
<u>[Sewer-Permit-fee]</u>	<u>[\$-25.00]</u>
<u>[Stub-in-fee]</u>	<u>[\$150.00]</u>
<u>[Trunkage-fee]</u>	<u>[\$425.00]</u>
<u>[Total-Fee+]</u>	<u>[\$600.00]</u>

(2) Adjustment in basic fee. Upon approval of the city manager, when a developer of a multiple user installation


has at his own expense made an extension to the sewer main or trunk line an "in lieu connection fee" of two hundred dollars for connecting into the extension constructed by the developer may be charged in lieu of the stub-in and trunkage fees.

(3) Inspection fee. The twenty-five dollar permit shall be paid in all cases, and a permit shall be required for each new account or customer added to the sewer system."

Section 2. This ordinance shall be in force and effect five (5) days from and after its passage and publication as required by law, provided, however, that the adjustment in connection fees herein adopted shall become effective as of January 1, 1979.


