

ORDINANCE NO. 2472

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO STREETS, INCLUDING ARTERIAL STREETS, ADOPTING A REVISED SIX-YEAR STREET IMPROVEMENTS PROGRAM AS REQUIRED BY R.C.W. 35.77 AND R.C.W. 47.26, AND AMENDING CHAPTER 19.08 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 19.08.010 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.010 Major arterial streets. The following streets of the city are designated major arterial streets:

Section 2. Section 19.08.020 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.020 Secondary arterial streets. The following streets of the city are designated secondary arterial streets:

Section 4. Section 19.08.040 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"19.08.040 Neighborhood collector streets. The following streets of the city are designated neighborhood collector streets:

Section 5. Section 19.08.050 of the Kirkland Municipal Code be and it hereby is repealed in its entirety.

Section 6. There is hereby added to the Kirkland Municipal Code a new section to be entitled Section 19.08.051 to read as follows:

NEW SECTION

19.08.051 Six-Year street and transportation improvement program including urban arterial improvement program.

Pursuant to Chapter R.C.W. 35.77 and R.C.W. Chapter 47.26 (relating to urban arterial improvements), the city shall maintain a perpetual six-year transportation and street construction and improvement program. Said program shall be in conformance to and in furtherance of the circulation element of the comprehensive land use policies plan adopted by Ordinance No. 2346 and shall include separate segments as to the following street classifications:

- a. Major arterial streets;
- b. Secondary arterial streets;
- c. Collector streets: both arterial and neighborhood;
- d. Residential streets: which shall include all streets and other public rights of way within the city not otherwise classified within segments a through c, inclusive.

Segments a, b, and c shall be deemed to constitute the "urban arterial street program" required by R.C.W. Chapter 47.26. Each segment shall after approval be reviewed and modified, revised and amended, if need be, by the city council upon recommendation from the Department of Public Service made at least annually and on or before July 1, in each year. Any modification, revision or amendment shall be adopted only following public hearing as required by R.C.W. Chapter 35.77 and R.C.W. Chapter 47.26. The six-year transportation and street construction and improvement program may consistent with this section be adopted, modified, revised, or amended by council resolution. A copy of the six-year transportation and street construction and improvement program and all amendments made thereto shall annually be filed with the Director of the Department of Transportation for the State of Washington as required by law.


Section 7. There is hereby added to Chapter 19.08, Kirkland Municipal Code, a new section, 19.08.070, to read as follows:

NEW SECTION 19.08.070 Residential Streets. All Streets and other public rights of way not otherwise classified in sections 19.08.010 through 19.08.040 of this Chapter shall be deemed to be residential streets.


Section 8. This ordinance shall be in force and effect five days from and after its passage by the City Council and publication as required by laws.


