AN ORDINANCE OF THE CITY OF KIRKLAND MAKING, AT THE REQUEST OF KING COUNTY, CERTAIN SCRIVENER CORRECTIONS TO THE LEGAL DESCRIPTION OF THE AREA ANNEXED TO THE CITY OF KIRKLAND BY ORDINANCE NO. 2479, AND AMENDING SECTION 4 OF ORDINANCE NO. 2479.

WHEREAS, the City of Kirkland heretofore in accordance with the manner required by state law annexed to the City of Kirkland the area described in Section 4 of Ordinance No. 2479, and

WHEREAS, King County has requested certain scrivener corrections to said legal description, now, therefore,

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 4 of Ordinance No. 2479 passed by the Kirkland City Council on October 1, 1979, be and it hereby is amended to read as follows:

"Section 4. The territory annexed to the City of Kirkland by this ordinance is described as follows:

The southwest quarter of the northwest quarter of the northwest quarter of Section 9, Township 25 North, Range 5 East W.M., together with the east 30 feet of the southeast quarter of the northeast quarter of the northeast quarter of Section 8, Township 25 North, Range 5 East W.M., except that portion within the City of Kirkland established by City Ordinance No. 995.

[The-following-described-property-located-in Section-9,-Township-25-N,-Range-5E-W,M.

Beginning-at-the-southwest-corner-of-the-northwest one-quarter;-thence-north-along-the-west-line-of Section-9-a-distance-of-1520-lineal-fect-more-or less-to-a-point-of-intersection-with-the-north line-of-Bide-A-We-Addition-(Volume-76-50)-extended westerly-and-to-the-point-of-beginning;-thence easterly-along-the-said-north-line-of-Bide-A-We Addition-a-distance-of-675-fect-more-or-less-to the-northeast-corner-of-said-plat-of-Bide-A-We; thence-northerly-along-a-line-parallel-to-the west-line-of-Section-9-a-distance-of-462-lineal fect-to-the-northeast-corner-of-Tax-Lot-43;-thence westerly-on-a-line-parallel-to-the-north-line-of Bide-A-We-Addition-a-distance-of-675-fect-more-or

less-te-the-west-line-of-Section-9;--thence southerly-along-the-west-line-of-Section-9-a distance-of-462-lineal-feet-more-or-less-tothe-point-of-beginning.]

Section 2. The Director of Administration and Finance is hereby directed to file certified copies of this amendatory ordinance with the King County Council and with the Secretary of State for the State of Washington, together with such additional STate offices as may be required by law or regulation.

Section 3. This ordinance shall become effective five days after the date of its passage and publication as required by laws.
