## **RESOLUTION R-5377**

A RESOLUTION OF THE CITY OF KIRKLAND APPROVING THE ISSUANCE OF A PROCESS IIB PERMIT AS APPLIED FOR IN THE PLANNING AND BUILDING DEPARTMENT FILE NO. ZON18-00783 BY THE LAKE WASHINGTON SCHOOL DISTRICT BEING WITHIN AN RSX 7.2 ZONE, AND SETTING FORTH CONDITIONS TO WHICH SUCH PROCESS IIB PERMIT SHALL BE SUBJECT.

WHEREAS, the Planning and Building Department has received an application for a Process IIB permit filed by the Lake Washington School District, the owner of said property described in said application and located within an RSX 7.2 zone; and

WHEREAS, pursuant to the City of Kirkland's Concurrency Management System, KMC Title 25, a concurrency application has been submitted to the City, reviewed by the responsible Public Works official, the concurrency test has been passed, and a concurrency test notice issued; and

WHEREAS, pursuant to the State Environmental Policy Act (SEPA), Chapter 43.21C RCW, and the Administrative Guideline and local ordinance adopted to implement it, the Lake Washington School District, as SEPA Lead Agency, performed SEPA review for the application; and

WHEREAS, said environmental checklist and determination have been available and accompanied the application through the entire review process; and

WHEREAS, the application has been submitted to the Hearing Examiner, who held hearing thereon at her special meeting of May 22, 2019; and

WHEREAS, the Hearing Examiner after her public hearing and consideration of the recommendations of the Planning and Building Department did adopt certain Findings, Conclusions, and Recommendations and did recommend approval of the Process IIB permit subject to the specific conditions set forth in said recommendation; and

WHEREAS, the City Council, in regular meeting, did consider the environmental documents received from the responsible official, together with the recommendation of the Hearing Examiner;

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland as follows:

<u>Section 1</u>. The findings, conclusions, and recommendation of the Hearing Examiner as signed by the Hearing Examiner and filed in the Planning and Building Department File No. ZON18-00783 is adopted by the Kirkland City Council as though fully set forth herein.

44 Section 2. The Process IIB permit shall be issued to the applicant subject to the conditions set forth in the recommendations herein above 45 46 adopted by the City Council. 47 48 Section 3. Nothing in this resolution shall be construed as excusing the applicant from compliance with any federal, state, or local 49 statutes, ordinance, or regulations applicable to this project, other than 50 expressly set forth herein. 51 52 53 Section 4. Failure on the part of the holder of the permit to initially meet or maintain strict compliance with the standards and 54 conditions to which the Process IIB permit is subject shall be grounds 55 for revocation in accordance with Ordinance 4671, as amended, the 56 57 Kirkland Zoning Ordinance. 58 59 Section 5. A complete copy of this resolution, including Findings, 60 Conclusions, and Recommendations adopted by reference, shall be certified by the City Clerk who shall then forward the certified copy to 61 the King County Department of Assessments. 62 63 64 Section 6.
