AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING THE DEFINITION OF AND CERTAIN FIRE PROTECTION REGULATIONS RELATING TO BUILDING OF SEVEN STORIES OR MORE AND AMENDING CHAPTER 21.08 OF THE KIRKLAND MUNICIPAL CODE, THE KIRKLAND UNIFORM BUILDING CODE.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Chapter 21.08 of the Kirkland Municipal Code which chapter is the uniform building code as adopted by the City of Kirkland, is hereby amended and supplemented as follows:

21.08.140 <u>UBC Section 1807 amended</u>. The title of Section 18.07 of the Uniform Building Code is amended to read:

"SPECIAL PROVISIONS FOR ALL BUILDINGS [FIVE] SEVEN OR MORE STORIES IN HEIGHT."

21.08.141 UBC Section 1807(a) further amended. Section 1807 of the Uniform Building Code is amended to read:

"Section 1807 (a) Scope. This section shall apply to all buildings [five] seven or more stories in height. Such buildings shall be provided with an approved sprinkler system in accordance with Section 1807(c) [and-safe-areas-of-refuge (compartmentation)-in-accordance-with-Section-1807(1).]"

"(1)--Areas-of-refuge-(compartmentation)-in-buildings containing-more-than-15,000-square-feet-per-floor;-areas-of refuge-conforming-to-the-following-shall-be-provided."]

21.08.150 UBC Section 1907 amended. The title of Section 1907 of the Uniform Building Code is amended to read:

"SPECIAL PROVISIONS FOR ALL BUILDINGS [FIVE] SEVEN OR MORE STORIES IN HEIGHT."

 $\frac{21.08.177 \ \text{UBC}}{\text{New}} \frac{\text{Section}}{\text{is hereby amended and supplemented by the addition of another}}{\text{item or subsection to be known as subsection } 3802(b) 7 \ \text{to read:}}$

7. All buildings four or more stories in height.

21.08.213 UBC Section 5501(c) Where Required. "Fire Alarm Systems shall be installed in all R-1 occupancies containing interior exit corridors, or 13 or more units, and in all other buildings when the total floor area of all floors exceeds 6000 square feet.

EXCEPTIONS: 1. A structure used exclusively for the parking or storage of passenger motor vehicles having a capacity of not more than nine persons per vehicle and all occupancies that fall within the classification of M-3 as listed in Appendix Chapter 15 need not have a Fire Alarm System. 2. Occupancies H and B containing an approved automatic fire extinguishing system throughout, unless the fire estinguishing system is otherwise required by this code."

<u>Section 2</u>. This ordinance shall be in force and take effect five days from and after its passage and publication as required by law.
