ORDINANCE NO. 2591

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO FEES AS REIMBURSEMENT FOR SERVICES RENDERED BY THE CITY OF KIRKLAND AND AMENDING SECTION 5.74.020 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council for the City of Kirkland as follows:

Section 1. Section 5.74.020 of the Kirkland Municipal Code is hereby amended to read as follows:

5.74.020 fee schedule established for payment to the City of Kirkland costs of certain services rendered by the [Kirkland-Police-Bepartment] City.

Persons seeking and obtaining the following services as provided by the <u>City of Kirkland [Pelice-Bepartment]</u> shall pay the following amounts for each instance such service is provided.

- (1) Police Department fingerprinting \$4.00
- (2) Police Department serving legal process and similar papers (whether or not successful) \$10.00
- (3) Applicants [te-take-the-written examinations-for-the-position-of-police-officer shall-reimburse-the-Gity-in-an-amount-not-less than-\$4-00-and-not-more-than-\$7-00-as-determined by-the-appropriate-testing-service-te-reflect actual-Gity-costs;] for all entry level positions requiring qualifying examinations whether such positions are covered by Civil Service or otherwise shall reimburse the City for the per capita cost charged to the City by the appropriate testing agency for the giving of such qualifying examinations. Qualifying examinations may include physical agility testing or similar performance testing as well as written examinations. The fee shall be paid to the City at the time of filing application, provided that a declaration of indigency by the applicant under this subsection shall excuse the imposition of the fee.

Section 2. Chapter 5.74 of the Kirkland Municipal Code is hereby amended to include a new section to read as follows:

<u>New</u> Section 5.74.030 Fees not refundable. No portion of any fee requested to be paid pursuant to this chapter shall be refunded or refundable provided that a fee may be refunded when a refund request is made to the City prior to the City having incurred any cost or expended effort in complying with the request for that service giving rise to the fee.

Section 3. If any section, subsection, sentence, clause, phrase, part or portion of this ordinance is for any reason held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

 $\underline{Section\ 4}.$ This ordinance shall be in force and take effect five days from and after its passage and publication as required by law.
