

ORDINANCE NO. 2594

AN ORDINANCE OF THE CITY OF KIRKLAND CHANGING THE STREET NAME DESIGNATION FOR CERTAIN STREETS WITHIN THAT AREA OF THE CITY OF KIRKLAND DESIGNATED IN THE LAND USE POLICIES PLAN (COMPREHENSIVE PLAN) AS PLANNED AREA 5.

Whereas, the area of the City of Kirkland lying east of Sixth Street between Kirkland Way and Central Way and designated in the Land Use Policies Plan (Comprehensive Plan) as Planned Area 5, contains some streets named in accordance with the King County Grid System designation and other streets named consistent with the City of Kirkland street designation pattern; and

Whereas, the streets within the areas immediately surrounding Planned Area 5 are all named or designated in accordance with the City of Kirkland street designation pattern; and

Whereas, the City Council believes that it is within the public interest to redesignate or rename all of the streets within Planned Area 5 consistent with the City of Kirkland street designation pattern;

Now Therefore, Be it Ordained by the City Council of the City of Kirkland as follows:

Section 1. Those certain public streets within the area designated in the City of Kirkland Land Use Policies Plan (Comprehensive Plan) as Planned Area 5 are hereby renamed or redesignated as follows:

NE 82nd Street to become Second Avenue
NE 84th Street to become Fourth Avenue
NE 85th Street to become Fifth Avenue
112th Avenue NE to become Tenth Street

Section 2. The City administration is hereby directed to take all steps necessary and required to effect changing the names of the streets set forth in Section 1 above including the installation of street identification signs, notifying the U.S. Postal Service, King County and such other public and private entities as may be appropriate.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the City Council and publication as required from law.
