

ORDINANCE NO. 2642

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO GARBAGE AND REFUSE COLLECTION, ESTABLISHING NEW COLLECTION SERVICE RATES AND AMENDING SECTION 16.12.030 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 16.12.030 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"16.12.030 Collection rates--Effective date. The rates to be charged for refuse collection service in the City shall be as follows:

- (1) RESIDENTIAL, SINGLE FAMILY:
One pickup per week, everything placed for collection:

<u>Location of cans or Ordinance units</u>	<u>Monthly rate</u>	
Curbside to 25 feet	\$4.15-	<u>\$4.80</u>
26 feet to 50 feet	4.58-	<u>5.28</u>
Additional 25-feet	.45-	<u>.50</u>

- (2) RESIDENTIAL, MULTI-FAMILY:

<u>(a) Cans or Ordinance Units</u>	<u>Rates</u>	
2 cans, 1 pickup per week	\$4.15-	<u>\$4.80</u>
Each additional can	.68-	<u>.75</u> per pickup

Note: Where more than one pickup per week is required, the charge for the additional pickups will be calculated on the additional can rate.

<u>(b) Detachable Containers--Capacity</u>	<u>Rates</u>	
1 yard	\$4.18-	<u>\$4.64</u> per pickup
1 1/4 yards	4.90-	<u>5.43</u> per pickup

	10 - 50 yards	\$2-73-	\$3.03 per yard*
	*Plus actual dump fee		

(3) NONRESIDENTIAL RATES:

(a)	<u>Cans or Ordinance Units</u>		<u>Rate</u>
	2 cans, 1 pickup per week	\$4-15-	\$4.80
	Each additional can	-68-	.75 per pickup

Note: Where more than 1 pickup per week is required, the charge for the additional pickups will be calculated on the additional can rate.

Wherever detachable containers are used having a capacity for which a rate has not been established, the director of administration and finance is authorized to establish a rate for such container, which shall be consistent with the ratio of container capacity to rate charge for the rate herein established.

Where detachable containers are so located as to require moving or "roll out" to permit direct mechanical pickup, the Director of Administration and Finance is authorized to establish a "Roll-out Surcharge" which shall be paid in addition to the rate herein established.

Section 2. This ordinance shall be in force and effect five (5) days from and after its passage and posting or publication as required by law, provided however, that the rates for refuse and garbage collection herein established shall become effective as of January 1, 1982.






