

ORDINANCE NO. 2669

AN ORDINANCE OF THE CITY OF KIRKLAND EXTENDING FOR AN ADDITIONAL FIFTEEN YEARS, THE GRANT OF A FRANCHISE TO KING COUNTY WATER DISTRICT NO. 1, TO CONSTRUCT, OPERATE, AND MAINTAIN A WATER PIPELINE WITHIN A PORTION OF LAKE WASHINGTON BOULEVARD AND AMENDING SECTION 1 OF ORDINANCE NO. 2153 HERETOFORE ADOPTED BY THE KIRKLAND CITY COUNCIL ON MAY 17, 1971.

Whereas, by Ordinance No. 2153 the City of Kirkland granted to King County Water District No. 1, a franchise to construct, operate, and maintain a water pipeline within a portion of Lake Washington Boulevard for a period of ten years; and

Whereas, acting under said ordinance, the City and King County Water District No. 1 entered into a franchise agreement providing for such franchise to extend for a period of 25 years; and

Whereas, the City council now finds that notwithstanding the ten-year franchise period established in Ordinance No. 2153, that it is in the interest of the City and King County Water District No. 1 to extend said franchise for an additional fifteen years, making the total 25 years contemplated by said franchise contract, now, therefore,

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Section 1 of Ordinance No. 2153 adopted by the Kirkland City Council in regular meeting on the 17th day of May, 1971 be and it hereby is amended to read as follows:

"Section 1. A franchise be, and the same hereby is given and granted to King County Water District No. 1, a Municipal Corporation, its Successors and Assigns, hereinafter referred to as the "The Holder", to construct, operate and maintain a water pipeline, together with the necessary appurtenances upon and across the following described portion of Lake Washington Boulevard with the City of Kirkland, Washington, for a period of [~~10~~] 15 years from the date of passage of this ordinance, subject to the terms and conditions hereinafter enumerated.

Beginning at a point on the westerly side of Lake Washington Boulevard a distance of approximately 225 feet southerly of the centerline of N.E. 52nd Street; thence northerly along a line 30 feet west of the centerline of Lake Washington Boulevard a distance of approximately 535 feet; thence easterly a distance of 7 feet; thence northerly

along a line 23 feet west of the centerline of Lake Washington Boulevard a distance of approximately 615 feet; thence easterly to the east margin of Lake Washington Boulevard."

Section 2. The franchise heretofore granted to King County, Water District No. 1, by Ordinance 2153 shall continue subject to all of the terms and conditions established in Ordinance No. 2153 through May 16, 1997 (that is to say for a period of 25 years from the date of original adoption of Ordinance No. 2153).

Section 3. This ordinance shall be in force and take effect five days from and after its passage by the council and publication or posting as required by law.


