ORDINANCE NO. 2736

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO REFUSE AND GARBAGE STORAGE AND COLLECTION, AMENDING CHAPTER 16.08 OF THE KIRKLAND MUNICIPAL CODE AND ADDING THERETO A NEW SECTION TO BE KNOWN AS SECTION 16.08.045

Be it ordained by the City Council of the City of Kirkland as follows:

'Section 1. Chapter 16.08 of the Kirkland Municipal Code relating to refuse and garbage is hereby amended by the addition of a new section to be known as Section 16.08.040 to read as follows:

16.08.045 "Waste Wheeler" Permitted. Lidded and wheeled plastic containers, specifically designed for garbage storage and collection, having a capacity not in excess of one-half yard and substantially similar in design and construction to those plastic garbage containers marketed under the trade name "Waste Wheeler", may at the option of a residential customer, be used in place of garbage cans. Such containers are herein referred to and identified as "Waste Wheelers".

If used, a Waste Wheeler must be placed for collection on the day scheduled for collection at the curb or alley for pick up by the garbage collector.

Any residential customer may, upon written request therefor, rent a Waste Wheeler from the City. The rental charge will be added as a separate item on the residential customer's bimonthy utility bill.

The rental rate to be charged single-family residential customers per Waste Wheeler shall be:

1/2 Yd. Waste Wheeler \$.95 per month
1/4 Yd. Waste Wheeler *\$ per month
*(Not presently available)

Section 2. Section 16.08.010 of the Kirkland Municipal Code is hereby amended to read as follows:

16.08.010 City's Right to Collect. The City reserves the right to and may have the option to require the separation of garbage or refuse and may prescribe the method of separate disposal thereof. "Hazardous waste" as defined in Section 2, Kirkland Ordinance 2708 shall not be mixed or comingled with garbage or refuse either in the storage thereof or the disposal thereof. As between the City and its garbage customers, ownership of all garbage, refuse and rubbish from the point of collection by the City's contract collector shall be deemed to be vested in the City.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.
