ORDINANCE NO. 2762

AN ORDINANCE OF THE CITY OF KIRKLAND UPDATING THE MODEL TRAFFIC ORDINANCE AND RELATING TO DRIVING WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Chapter 12.60 of the Kirkland Municipal Code, entitled MODEL TRAFFIC ORDINANCE, is hereby repealed.

Section 2. There is hereby created a new chapter to be known as Chapter 12.60, entitled MODEL TRAFFIC ORDINANCE, and to read as follows:

12.60.010 RCW Chapter 46.90 adopted--Exceptions:

A. Except as otherwise provided, RCW Chapter 46.90 (Washington Model Traffic Ordinance), hereinafter referred to as MTO, is adopted as part of Chapter 12.60 of the Kirkland Municipal Code, providing that the following sections of RCW Chapter 46.90 are not adopted:

C. MTO (RCW) 46.90.427 is adopted by reference except for the following section:

Provided that 46.61.515 is adopted as amended by Chapter 150, Laws of 1983 and Section 21, Chapter 165, Laws of 1983, and further, provided that if any penalty prescribed therein is adjudged to exceed the maximum penalty authorized then, such penalty shall be the maximum penalty the City council has the power to impose.

<u>12.60.020 Other laws adopted.</u> The following laws of Washington are adopted by reference:

Sections 25, 27, 28, 33, 40 and 44, Chapter 165, Laws of 1983. For purposes of this ordinance "legislature" shall include the City council.

Section 3. KMC 12.04.030, entitled Serious Crimes designated, is hereby repealed.

Section 4. There is hereby created a new section to be known as KMC 12.04.030, entitled serious crimes designated, and to read as follows:

<u>12.04.030 Serious Crimes designated</u>. The following sections of Title 12 of this code are designated serious crimes (designation by other than KMC numbers refers to sections as incorporated by reference through KMC Chapter 12.60): RCW

Section 5. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.

<u>Section 6</u>. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.
