AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO THE DEPARTMENT OF EMERGENCY SERVICES AND AMENDING CHAPTER 3.45 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Section 3.45.030 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

"It shall be the duty of the director to create and maintain a basic emergency plan for man made and natural disasters that may take place within the City. In addition, the director shall:

- 1. Prepare an emergency operating plan for the City conforming to the County and State emergency plan and program;
- 2. Be responsible for the organization, administration and operation of the emergency services department;
- [1+] 3. Act as liaison officer between the City and County, State and Federal offices of emergency services or civil defense;
- [2.] 4. Coordinate mutual aid and automatic aid agreements with neighboring municipalities;
- [3 $_{\tau}$] 5. Identify those disasters with the greatest threat to life and to property in the City; and
- [4. Have the responsibility for implementing and operating the basic emergency plan for the safety and well-being of the Gity and its inhabitants.]

6. Control and direct the effort of the emergency operations organization of this City for the accomplishment of the emergency plan and its mission for the safety and well-being of the City and its inhabitants.

Section 2. There is hereby added to Chapter 3.45 of the Kirkland Municipal Code a new section to read as follows:

3.45.035 Emergency operation staff. The director and staff of the emergency services department shall function under the direction of the City Manager in accordance with RCW 35A.13.080 and RCW 35A.13.090 provided, however, that only during such time of civil emergency as there may be in effect, a proclamation issued by the mayor, pursuant to Chapter 3.20, Kirkland Municipal Code and RCW 35A.11.020, the director and his staff shall function under the direction of the mayor in accordance with Annex A of the Kirkland Emergency Plan.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.
