

ORDINANCE NO. 2820

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO TITLE 11,  
THE MUNICIPAL CRIMINAL CODE.

Be it ordained by the City Council of the City of  
Kirkland as follows:

Section 1. Chapter 11.12 of the Kirkland Municipal  
Code is hereby amended by adding a new section to be known  
as Section 11.12.020, entitled Unlawful Reports, and to  
read as follows:

(S)11.12.020 Unlawful Reports. It is unlawful  
for any person to: (1) knowingly falsely report a  
crime to any police officer; or (2) initiate contact  
with a public servant and make a knowingly false  
statement to a public servant.

Section 2. KMC 11.36A.140 of the Kirkland Municipal  
Code is hereby amended as follows:

11.36A.140 Court--Duties.

RCW 10.99.040, as amended by Section 22, Chapter 263,  
Laws of 1984, is adopted by reference. The written  
order provided for in RCW 10.99.040(2) shall bear the  
legend: Violation of this order is a criminal  
offense under KMC 11.36A.140, KMC 11.36A.140 and will  
subject a violator to arrest.

Section 3. Chapter 11.36A of the Kirkland Municipal  
Code is hereby amended by the addition of new sections to  
read as follows:

(S)11.36A.210 Violation of Order for Protection.  
Section 12, Chapter 263, Laws of 1984 is adopted by  
reference.

11.36A.220 Any Proceeding is Additional Remedy.  
Section 16, Chapter 263, Laws of 1984 is adopted by  
reference.

11.36A.230 Liability for Arrest.  
Section 17, Chapter 263, Laws of 1984 is adopted by  
reference.

Section 4. Chapter 11.91 of the Kirkland Municipal  
Code is hereby amended by adding a new section to be known  
as Section 11.91.070, entitled Conduct on Buses, and to  
read as follows:



11.91.070 Conduct on Buses. Section 1, Chapter 167, Laws of 1984 is adopted by reference.

Section 5. KMC 11.04A.130 is hereby amended as follows:

11.04A.130 Serious Crimes designated.

Section 8. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.


Section 9. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.

Passed by majority vote of the Kirkland City Council in regular, open meeting this 2nd day of July, 1984.




