

ORDINANCE NO. 2823

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING SECTION 5 OF ORDINANCE NO. 2821 ADOPTED JULY 2, 1984, TO CORRECT A TYPOGRAPHICAL ERROR IN BALLOT PROPOSITION TWO.

Be it ordained by the City Council of the City of Kirkland, Washington, as follows:

Section 1. Section 5 of Ordinance No. 2821 adopted July 2, 1984, be and it hereby is amended to read as follows:

"Section 5. The Director of Administration and Finance is hereby directed to certify to the King County Director or Records and Elections as supervisor of elections, a copy of this ordinance and the propositions to be submitted at the special election to be held in the City on September 18, 1984 in the form of ballot titles as follows:

PROPOSITION ONE  
"WAVERLY SCHOOL SITE" ACQUISITION BONDS

For the capital purpose of acquiring surplus school land commonly known as the "Waverly School Site" from Lake Washington School District 414, shall the City borrow \$1,600,000 and issue its registered general obligation bonds therefor, payable by annual excess property tax levies authorized under RCW 84.52.056 to be made without limitation as to rate or amount and maturing in not more than twenty years from the date of issue all as provided in Ordinance 2821 of said City, passed and approved July, 1984?

PROPOSITION TWO  
JUANITA BAY PROPERTY ACQUISITION BONDS

For the capital purpose of acquiring land, being the non-city owned portion of the former Juanita Golf Course, adjacent to Juanita Bay, including uplands, shoreline and associated wetlands, shall the City borrow \$645,000 and issue its negotiable general obligation bonds therefor, payable by annual excess property tax levies authorized under RCW 84.52.056 to be made without limitation as to rate [of] or amount and maturing in not more than 20 years from the date of issue, all as

provided in Ordinance 2821 passed and approved  
July 7, 1984?

Section 2. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.
