

ORDINANCE 2855

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO ANIMAL CONTROL, THE PUBLIC HEALTH AND SAFETY, AND ADOPTING BY REFERENCE CHAPTER 11.12 (RABIES CONTROL) AND CHAPTER 11.32 (GUARD DOG REGULATION) BY ADDING TWO NEW SECTIONS TO CHAPTER 8.04 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Section 8.04.040 of the Kirkland Municipal Code be and it hereby is amended to read as follows:

8.04.040 County ordinances - copies filed. The City shall maintain available at all times for the use of the general public not less than [~~three~~ copies] one copy of the King County ordinance and King County Administrative Code provisions adopted by reference in Section 8.04.010, 8.04.060, 8.04.070 and 8.04.080.

Section 2. There is hereby added to Chapter 8.04 of the Kirkland Municipal Code a new section to read as follows:

8.04.080 Rabies control. The rules and regulations of King County relating to the protection of the public health with respect to the existence spread and control of rabies being Sections 11.12.010 through 11.12.060, inclusive, of the King County Administrative Code, are by this reference adopted as a part of this chapter.

Section 3. There is hereby added to Chapter 8.04 of the Kirkland Municipal Code, a new section to read as follows:

8.04.070 Regulation of guard dogs. The rules and regulations of King County relating to the training, selling and conveying of guard dogs and the use of such animals for the protection of person and/or property being Sections 11.32.010 through 11.32.120 of the King County Administrative Code as adopted by King County Ordinance 3232, are by this reference adopted as a part of this chapter.

Section 4. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and posting or publication, as required by law.
