AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO TRAFFIC AND PEDESTRIAN SAFETY, THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES IN PROHIBITED OR RESTRICTED AREAS AND AMENDING SECTIONS 12.44.040, 12.44.080 AND 12.44.085 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of the City of Kirland as follows:

Section 1. Section 12.44.040 of the Kirkland Municipal Code is hereby amended to read as follows:

12.44.040 Parking prohibited on certain streets at certain times. Pursuant to this title and Sections 12.44.050 through 12.44.100, it is hereby declared to be unlawful for any person to park or stand a motor vehicle in the following areas during the hours indicated:

<u>Parking restriction area</u>	<u>Hours parking prohibited</u>
A. <u>No Parking At Any Time</u>	
1. East side of Lake Street between Central Way and Kirkland Avenue	At all times
2. East side of Lake Street South between Kirkland Avenue and a point 125 feet south of the center- line of Kirkland Avenue (the alley south of Kirk- land Avenue)	At all times
3. South side of Central Way between Lake Street and Sixth Street	At all times
4. South side of Northeast 85th Street between Sixth Street and 120th Avenue Northeast	At all times
5. North side of Northeast 85th Street between 122nd Avenue Northeast and Sixth Street	At all times

6. North side of Third Avenue
between First Street and
Second Street At all times

B. No parking between the hours of
 4 p.m. to 6 p.m. and two-hour
 limited parking between the
 hours of 9 a.m. to 4 p.m.

6. West side of Lake Street
 between Commercial Avenue
 and Kirkland Avenue 4 p.m. to 6 p.m.

7. East side of Lake Street
 between a point 125 feet
 south of the centerline
 of Kirkland Avenue (alley
 south of Kirkland Avenue)
 and a point 100 feet south
 of Second Avenue 4 p.m. to 6 p.m.

Section 2. Section 12.44.080 of the Kirkland
 Municipal Code is hereby amended to read as follows:
12.44.080 Restricted parking zones established.

Restricted parking zones shall be established as
 follows:

<u>ZONES</u>	<u>PARKING RESTRICTION</u>
Zone 1	[10] 30 minute parking
Zone 2	1 hour parking
Zone 3	2 hour parking
Zone 4	3 hour parking
Zone 5	4 hour parking
Zone 5-A	6 hour parking
Zone 6	8 hour parking
Zone 7	No parking permitted at any time
Zone 8	No parking--7 a.m. to 9 a.m.
Zone 9	No parking--4 p.m. to 6 a.m.
Zone 10	No overnight parking all days
Zone 11	No overnight parking Sunday, Tuesday, Thursday
Zone 12	No overnight parking Monday, Wednesday, Friday

Zone 13

Loading zone only--No parking allowed except that bona fide delivery vehicles may be allowed to stand in this zone for such time as may be reasonably necessary for the making of delivery or pickup of goods at a destination within eighty feet of that portion of the street occupied by the delivery vehicle

Zone 14

No parking permitted except that vehicles with boat trailer attached may park seven days a week (including holidays) for a period not to exceed twenty minutes for the purpose of rigging and securing boat to trailer.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017 Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council, or on July 1, 1986, whichever shall last occur.

SUMMARY OF ORDINANCE 2943

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO TRAFFIC AND PEDESTRIAN SAFETY, THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES IN PROHIBITED OR RESTRICTED AREAS AND AMENDING SECTIONS 12.44.040, 12.44.080 AND 12.44.085 OF THE KIRKLAND MUNICIPAL CODE.


Section 1. Amends provisions of Kirkland Municipal Code Section 12.44.040 to prohibit parking at all times on the north side of Third Avenue between First Street and Second Street.

Section 2. Amends provisions of Kirkland Municipal Code Section 12.44.080 to provide for a thirty minute restricted parking zone.

Section 3. Authorizes publication of the Ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.17 Kirkland Municipal Code and establishes the effective date as five days after summary of publication, or July 1, 1986, whichever shall last occur.

The full text of this Ordinance will be mailed without charge to any person upon request made to the Director of Administration and Finance for the City of Kirkland. The Ordinance was passed by the Kirkland City Council at its regular meeting on the 7th day of April, 1986.
