

ORDINANCE NO. 2995 *Repealed 0-3238*

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, RELATING TO THE KIRKLAND WATER-SEWER SYSTEM, ADJUSTING CERTAIN RATES FOR WATER AND SEWER SERVICE AND AMENDING CHAPTER 15.24 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 15.24.020 of the Kirkland Municipal Code relating to monthly service rate for water service is hereby amended to read as follows:

Section 15.24.020 Basic Water Rate - Residential. Basic residential water rates are as follows:

- (1) Single family residence - [~~\$4.00~~] \$4.50 per month;
- (2) Multi-family residence, including duplexes \$2.50 per month per unit or apartment;
- (3) The single family basic monthly rate shall include [~~two hundred~~] two hundred fifty cubic feet of water consumed;
- (4) The basic rate shall be charged whether the premises are occupied or vacant.

Section 2. Section 15.24.040 of the Kirkland Municipal Code, relating to monthly service and consumption rates for water service, is hereby amended to read as follows:

Section 15.24.040 Water Consumption Charge. In addition to the basic monthly rate, the charge for water consumption during the billing period (bi-monthly) shall be:

- (1) For residential customers: [~~Forty eight~~] eighty cents per one hundred cubic feet of water consumed;
- (2) For non-residential customers: [~~Fifty three~~] eighty five cents per one hundred cubic feet of water consumed;
- (3) Where the basic rate includes some water consumption (single family residential customers) the consumption rate shall be calculated on water consumed in excess of the amount included in the basic rate.

Section 3. Section 15.24.070 of the Kirkland Municipal Code relating to monthly sewer service rates is hereby amended to read as follows:

Section 15.24.070 Monthly sewer rates. The monthly sewer charge required to be paid to the city by customers of the sewer system is established as follows:

- (1) Single family residence: [~~twelve dollars and seventy five cents~~] fourteen dollars and forty cents.



(2) Multi-family residence, including duplex: [~~One dollar and fifty cents~~] Two dollars and fifty cents per month per unit or apartment, plus [~~one dollar and forty-two cents~~] one dollar and sixty cents per one hundred cubic feet of water consumed.

(3) All other sewer customers: [~~one dollar and forty two cents~~] one dollar and sixty cents per one hundred cubic feet of water consumed; provided, however, that the monthly rate per customers or establishment shall be not less than [~~twelve dollars and seventy five cents~~] fourteen dollars and forty cents.

Section 4. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
