

ORDINANCE No. 3008

AN ORDINANCE OF THE CITY OF KIRKLAND WITHDRAWING ITS APPROVAL OF THE TRANSFER OF THE CATV FRANCHISE GRANTED BY ORDINANCE 2490 FROM TELE-VUE SYSTEMS, INC. D/B/A VIACOM CABLEVISION, A WHOLLY OWNED SUBSIDIARY OF VIACOM INTERNATIONAL TO VIACOM CABLEVISION OF PACIFIC NORTHWEST, INC. AND REPEALING ORDINANCE 2998 ADOPTED DECEMBER 15, 1986.

Whereas, the City of Kirkland, by Ordinance 2998 approved the request of Televue Systems, Inc. and its parent, Viacom International, Inc. to transfer the CATV franchise held by Televue Systems, Inc. to Viacom Cablevision of Pacific Northwest, Inc.; and

Whereas, thereafter Viacom Cablevision of Pacific Northwest, Inc. failed timely to meet the conditions of such transfer; and

Whereas, Televue Systems, Inc. and its parent, Viacom International, Inc., have now advised the City that Televue Systems, Inc. will continue to be bound by all of the applicable cable franchise terms and conditions in Kirkland following corporation reorganization of its parent, Viacom International, Inc., as a subsidiary of National Amusements, Inc.; now, therefore,

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Ordinance 2998 adopted December 15, 1986 and entitled:

"An ordinance of the City of Kirkland approving the transfer of the CATV franchise granted by Ordinance 2490 from Televue Systems, Inc., d/b/a Viacom Cablevision, a wholly owned subsidiary of Viacom International, Inc., to Viacom Cablevision of Pacific Northwest, Inc., a wholly owned subsidiary of Viacom International, Inc., and amending Ordinance 2490"

be and it hereby is repealed.

Section 2. The holder of the franchise granted by Ordinance 2490 continues to be Televue Systems, Inc., d/b/a Viacom Cablevision, a wholly owned subsidiary of Viacom International, Inc., following its acquisition by National Amusements, Inc.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
