AN ORDINANCE OF THE CITY OF KIRKLAND RE-ESTABLISHING THE KIRKLAND LIBRARY BOARD AS A BOARD ADVISORY TO THE KIRKLAND CITY COUNCIL AND TO THE KING COUNTY RURAL LIBRARY DISTRICT AND ITS DESIGNATED LIBRARIAN FOR THE KIRKLAND LIBRARY AND REPEALING ORDINANCE 616

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Declarations:

Under the authority of RCW 27.12.040, the City of Kirkland contracts for library service with the King County Rural Library District. Pursuant to the contract, the Library District provides full and complete library service, including books, library supplies and personnel, including librarian. The Library building, its equipment and care and maintenance are the responsibility of the City of Kirkland. Books and other library properties belonging to the City of Kirkland as of June 1, 1968 remain the property of the City of Kirkland, but are available for use by the King County Rural Library System. By virtue of said contract, the facilities of the King County Rural Library System and the Seattle Public Library System are available to any Kirkland resident.

Section 2. Kirkland Library Board:

The Kirkland Library Board shall be composed of five (5) members who shall be residents of the City of Kirkland appointed by the City Council for terms of <u>five (5)</u> years four (4) years and shall otherwise serve at the pleasure of the City Council.

The Board shall serve as advisory to the City Council and to the City Manager with respect to those matters directly relating to the operation of the library facilities within Kirkland, relationship with the King County Rural Library System and the operation and maintenance of the City owned Library building and facilities. The Kirkland Library Board shall further serve as liason between the City of Kirkland and the King County Rural Library District and its designated librarian for the Kirkland Library.

Section 3. The Department of Administration and Finance shall be responsible for the care, maintenance and repair of the Kirkland Library building, preparation of estimates for the appropriation of funds necessary for the care, maintenance and operation of the Library building and payments as required under the contract with the King County Rural Library System. The Department of

: :

Administration and Finance shall further be responsible for the authorization and accounting of expenditures to be charged to the City with respect to the management and operation of the Library building and facilities.

Section 4. The Library Board may participate in and support activities which promote the Library and the use of the facilities by the residents of the City of Kirkland, as well as programs to solicit contributions to either the Kirkland Library fund or the King County Rural Library District fund. All expenditures or contracts for expenditures to be charged against the Kirkland Library fund or otherwise paid by the City of Kirkland shall first be submitted to and approved by the Finance Director for the City of Kirkland.

Section 5. The members of the Kirkland Library Boad so serving immediately prior to the effective date of this Ordinance shall continue to so serve until the expiration of their existing respective terms.

<u>Section 6.</u> Sections 1 through 5, inclusive, of this Ordinance shall constitute a new chapter in Title 3 of the Kirkland Municipal Code.

Section 7. Ordinance 616 of the City of Kirkland is hereby repealed.

<u>Section 8.</u> This ordinance shall be in force and effect five (5) days from and after its passage by the Kirkland City Council and publication, as required by law.
