

ORDINANCE 3093

AN ORDINANCE OF THE CITY KIRKLAND ACCEPTING FOR DEPOSIT IN A SPECIAL FUND, A DONATION OF \$30,000 FROM THE KIRKLAND COMMUNITY CENTER ACTION COUNCIL, TO BE USED BY THE CITY ONLY FOR KIRKLAND SENIOR CENTER, CAPITAL IMPROVEMENTS, EQUIPMENT AND/OR FURNISHINGS; AND CREATING SAID FUND.

Whereas, the Kirkland Community Center Action Council, a Washington non-profit corporation, has offered to donate to the City of Kirkland the sum of \$30,000, to be used only for capital improvements, equipment, and/or furnishings for the Kirkland Senior Center; and

Whereas, the City Council is authorized to accept such gifts or donations, subject to conditions imposed by the donator, now, therefore

Be it ordained by the City Council of the City Kirkland as follows:

Section 1. The City of Kirkland hereby accepts the donation from the Kirkland Community Center Action Council, a Washington non-profit corporation, in the amount of \$30,000, subject to the condition that said funds be only used for capital improvements, equipment and/or furnishings for the Kirkland Senior Center.

Section 2. There is hereby established, pursuant to RCW Chapter 35A.37 and RCW 35.21.070 et sequence, a special fund, which shall be identified as the Senior Center Special Fund for Senior Center, capital improvements, equipment, and/or furnishings. Expenditures for said purposes may be paid wholly or in part from said fund.

Section 3. The monies in the fund herein established may be allowed to accumulate from year to year, until the City Council determines to expend the monies in the fund for the purpose or purposes herein and above specified, provided that any monies in the fund shall never be expended for any other purpose or purposes than those specified, without an approving vote of a three-quarters majority of the members of the City Council. Any monies in the fund at the end of the fiscal year shall not lapse, nor shall the same be a surplus available, or which may be used for any other purpose or purposes than those specified, except as in this Ordinance provided.

Section 4. At such time as the donation of \$30,000 from the Kirkland Community Action Council has been



received by the City of Kirkland, the Kirkland City Treasurer is directed to deposit said donation into the fund herein created.

Section 5. The City Council may direct the transfer to or deposit in said fund such additional donations, gifts, or other monies as it may authorized by ordinance, resolution, or motion duly passed. Authorization to expend monies from said fund shall be subject to approval by the City Council. Such approval may be expressed by the inclusion of an item therefore in the annual budget, or such other appropriate action by the City Council as may be permitted by law. Such authorization shall not lapse at the end of the budgetary year, but may be carried forward, provided that such carried forward appropriation shall be included and so identified in the budget for succeeding years.

Section 6. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
