#### ORDINANCE No. 3144

AN ORDINANCE OF THE CITY OF KIRKLAND APPROVING AN AGREEMENT WITH KING COUNTY FIRE PROTECTION DISTRICT NO. 41 FOR TRANSFER OF ASSETS FOLLOWING ANNEXATION.

Whereas, Chapter 35A.14 RCW requires that King County Fire Protection District No. 41 transfer a portion of its assets to the City following the annexation of a portion of the District as of January 1, 1988; and

Whereas, an agreement has been submitted to the Kirkland City Council identified as "Agreement on Transfer of Assets Following Annexation", which agreement is found to be in the best interest of the City, now, therefore

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. The City Manager is hereby authorized and directed to sign on behalf of the City of Kirkland the "Agreement on Transfer of Assests Following Annexation" with King County Fire Protection District No. 41. A copy of said agreement is attached to this ordinance as Exhibit A and by this reference incorporated herein and the contents of said agreement are approved.

Section 2. The City Manager is authorized to execute such documents or take such other action as is necessary to accomplish the transfer of title to assets as described in said agreement.

<u>Section 3</u>. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.

RESOLUTION OF THE BOARD OF COMMISSIONERS OF KING COUNTY FIRE PROTECTION DISTRICT NO. 41 ADOPTING A NEW JOINT AGREEMENT WITH THE CITY OF KIRKLAND

WHEREAS, the Board of Commissioners has reviewed its joint agreement for fire services with the City of Kirkland and finds that certain amendments thereto appropriate, and

WHEREAS, the Board of Commissioners has reviewed "Joint Agreement, City of Kirkland--King County Fire District No. 41, Contract for Fire Protection Services, December 20, 1988" attached hereto and incorporated by reference and finds the same to be in the best interest of the District, and

WHEREAS, it is the intention of the Board of Commissioners to approve said contract as a complete substitution for and to supersede the existing contract for joint services.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COM-MISSIONERS OF KING COUNTY FIRE PROTECTION DISTRICT NO. 41 AS FOLLOWS:

Section 1. The "Joint Agreement, City of Kirkland--King County Fire District No. 41, Contract for Fire Protection Services, December 20, 1988" attached hereto and incorporated herein by reference is approved as the agreement for delivery of joint fire protection and emergency aid services, which will supersede all prior agreements with the City of Kirkland.

Section 2. The Secretary of the District is authorized to execute said agreement on behalf of the District.

Section 3. The transfer of vehicles and personal property contained in paragraph 8 of the agreement is expressly approved and the Secretary of the District is authorized to

execute such transfers as are necessary to place title to the vehicles now owned by the District in the name of the City.
