

ORDINANCE NO. 3194

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO THE COLLECTION AND DISPOSAL OF SOLID WASTE (GARBAGE), THE RATES TO BE CHARGED THEREFORE BY THE CITY OF KIRKLAND AND AMENDING SECTIONS 16.12.010, 16.12.030 AND 16.12.035 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. KMC Section 16.12.010 is hereby amended to read as follows:

16.12.010 Award of Contract.

No later than one hundred fifty days prior to the expiration of any existing contract for garbage collection, the city shall commence preparation of specifications, and thereafter advertise and call for bids and from bids received award the contract for the collection and disposal of all [~~refuse~~] solid waste within the city; provided, however, that the city council, by resolution, may authorize the city manager or the director of the department of administration and finance as his delegate to negotiate for the award of a new contract for garbage collection or the extension of any existing garbage collection contract. [~~No contract nor the extension of an existing contract shall run for a period in excess of five years.~~] Upon the award of contract, the contractor shall furnish a corporate surety bond to the city in the sum of [~~one~~] five hundred thousand dollars conditioned upon full and faithful performance of his contract and compliance with all laws, statutes, ordinances, rules and regulations relating to his business and the collection and disposal of [~~refuse~~] solid waste. Such contract shall contain a prohibition against assignment thereof or transfer of any interest therein without consent of the city and it shall contain a suitable provision provided for the forfeiture of the agreement for nonperformance of the terms and conditions of the contract and this title.

Section 2. KMC Section 16.12.030. Effective midnight December 31, 1989, Section 16.12.030 of the Kirkland Municipal Code as last amended by Ordinance 2994, is repealed and replaced by the following new section:

16.12.030 Collection Rates - Effective
Date.

The rates to be charged for solid waste collection service in the City shall be as follows:

- (3) Wherever detachable containers are used having a capacity for which a rate has not been established, the Director of Administration and Finance is authorized to establish a rate for such container, which shall be consistent with the ratio of the container capacity to rate charged for the rate herein established.

(4) The rates established by this Section shall be effective beginning January 1, 1990.

Section 3. KMC Section 16.12.035 is hereby amended to read as follows:

16.12.035 Monthly Collection Rate - Determination.

The monthly [~~refuse~~] solid waste collection rate to be charged, billed and paid by each customer, shall be the sum of the appropriate customer or service classification rate set forth in Section 16.12.030, together with an additional amount equal to the proportionate share of the gross revenue tax levied upon refuse collection business activity by the city pursuant to Section 5.08.050 of the Kirkland Municipal Code, which amount may be separately itemized in the billing statement going to the customer, together with such solid waste taxes as may be levied by the State of Washington.

This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law, provided that the reates established in Section 2 shall become effective January 1, 1990.
