

AN ORDINANCE OF THE CITY OF KIRKLAND  
RELATING TO THE WATER/SEWER SYSTEM,  
ESTABLISHING NEW RATES TO BE CHARGED FOR  
WATER AND SEWER SERVICE AND AMENDING CHAPTER  
15.24 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of  
the City of Kirkland as follows:

Section 1. Repealer. Section  
15.24.010, 15.24.020, 15.24.030, 15.24.040  
and 15.24.070 are each, effective December  
31, 1990, repealed; provided, however, the  
consumption rates (both water and sewer)  
established in said sections shall as to  
those water and sewer customers billed on  
the City of Kirkland billing cycles number 6  
and number 8 remain in effect until midnight  
January 31, 1991.

Section 2. Section 15.24.010 is hereby  
re-enacted to read as follows:

15.24.010 Monthly Service and  
Consumption Rates Established.

The monthly service rates to be paid to  
the City by customers of the water-sewer  
system are established as set out in this  
Chapter. The basic or minimum rate for both  
water and sewer shall be charged whether the  
premises are occupied or vacant.

Section 3. Section 15.24.020 re-  
enacted.

15.24.020 Monthly Water Rates.

The monthly water charge required to be  
paid to the City by customers of the water  
system is established as follows:

<u>Customer Class</u>	<u>Rates</u>
a. Single family residential:	
(1) Basic charge (includes 200 cubic feet of water consumed)	\$ 4.75
PLUS	

- (2) Water consumption charge -  
201 cubic feet to 1,200  
cubic feet \$ 1.00

over 1,200 cubic feet \$ 1.40

## b. Multi-family residential

consumed

Section 4. Section 15.24.070  
Re-enacted.

15.24.070 Monthly Sewer Rates.

The monthly sewer charge required to be paid to the City by customers of the sewer system is established as follows:

- a. Single family residential \$ 18.80
- b. Multi-family residential
  - (1) Basic charge \$ 1.70  
per residential unit.
  - PLUS
  - (2) Water consumption charge \$ 2.35  
per 100 cubic feet of water consumed
- c. All other customers, including commercial:
  - (1) Water consumption charge \$ 2.35  
per 100 cubic feet of water consumed
  - But not less than
  - (2) Minimum charge \$ 18.80

Section 5. Section 15.24.080 Amended.

Section 15.24.080 is hereby amended to read as follows:

15.24.080 Exempt Meters - Non-Residential Customers Only.

Where the use of water by a non-residential customer is such that a portion of all of the water used does not flow into the sewer system, but is lost by evaporation, irrigation, sprinkling, or other causes, or is used in manufacturing or in a manufacturer product and the person in control provides proof of this fact and installs other measuring devices approved by the City Manager acting through the Public Works Director to measure the amount of

water so used or so lost, no charge shall be made for sewer service because of water so used or lost.


Section 6. Effective date for new rates:

The monthly service and consumption rates for water and sewer customers established in this Ordinance shall go into effect and become the rates to be charged as of January 1, 1991, provided, however, that the water consumption charge for both water and sewer as to those customers billed on City of Kirkland billing cycles number 6 and number 8 shall go into effect February 1, 1991.


Section 7. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
