AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO WATER CUSTOMER RATES, PROVIDING FOR AN INCREASE IN SAME TO REFLECT THE INCREASE IN THE CITY OF SEATTLE WHOLESALE PRICE OF WATER, AND AMENDING TABLE 15.24.020 OF THE KIRKLAND MUNICIPAL CODE (MONTHLY WATER CUSTOMER RATE CHARGES)

WHEREAS, the City of Kirkland purchases through Rose Hill Water District Seattle City water to be distributed to Kirkland water customers, and

WHEREAS, the Seattle Water Department has increased the price of wholesale water provided to its Eastside purveyor customers, and

WHEREAS, it is necessary to increase the monthly water rates charged by the City of Kirkland to its water customers to reflect said increase in the wholesale price of water purchased by the City,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Table 15.24.020 of the Kirkland Municipal Code which establishes the monthly water charge required to be paid to the City by customers of the Kirkland water system is amended to read as follows:


Section 2. Effective date for new water rates: The monthly service and consumption rates for water customers established in Section 1 of this ordinance shall go into effect and become the rates to be charged as of April 1, 1991, provided, however, that the water consumption charge for those water customers billed on Kirkland Billing Cycles No. 2 and No. 4 shall go into effect May 1, 1991.

Section 3. This ordinance shall be in force and effect five days from and after its


passage by the Kirkland City Council and publication as required by law.
