AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KIRKLAND RELATING TO CITY JAIL CUSTODIAL CARE STANDARDS AND AMENDING KIRKLAND MUNICIPAL CODE (KMC) SECTIONS 11.92.010 AND 11.92.020.

Be it ordained by the City Council of the City of Kirkland as follows:

<u>Section 1</u>: KMC Section 11.92.010 is hereby amended to read as follows:

11.92.010 Adoption.

The [e]Custodial [e]Care [s]Standards for [h]Holding [f]Facilities, as adopted by the board of directors of the Washington Association of Cities in the format prepared and approved by the Washington Association of Sheriffs and Police Chiefs, are hereby adopted by this reference [and-set-out-as-Exhibit-A-following this-chapter], to be the custodial care standards for the Kirkland city jail, which jail facility is classified as a holding facility. A copy of said standards, as adopted herein by reference, shall be authenticated and recorded by the Kirkland city clerk [along-with-the ordinance-codified-in-this-chapter,-when adopted]. Not less than one copy of said standards, herein adopted by reference, shall be filed in the office of the Kirkland city clerk for use by the public. Not less than one copy thereof shall also be maintained in the offices of the Kirkland police department.

<u>Section 2:</u> KMC Section 11.92.020 is hereby amended to read as follows:

11.92.020 Definitions.

The following words or phrases as used in the custodial care standards, adopted by reference in Section [1-12-010,-shall-mean-as-they-are defined-in-this-section-]11.92.010 herein, shall mean:

(1) <u>"Body Cavity" means the stomach or rectum</u> of a person and the vagina of a female person. For the purposes of this chapter, the mouth is not a body cavity.

(2) <u>"Body Cavity Search" means the touching</u> or probing of a person's body cavity, whether or not there is actual penetration of the body cavity.

(3) "Chief law enforcement officer" means the Kirkland chief of police.

(4) "Contraband" means any substance or item not specifically permitted by jail administration.

(5) "[The]Director of the department of corrections" means the uniformed police officer designated by the chief law enforcement officer to be the officer in charge of the Kirkland jail facility.

(6) "Strip Search" means having a person remove or arrange some or all of his or her clothing so as to permit an inspection of the genitals, buttocks, anus, or undergarments of the person or breasts of a female person.

<u>Section 3:</u> This ordinance shall be in full force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
