AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO SCHOOL IMPACT FEES AND AMENDING SECTION 27.08.150 OF THE KIRKLAND MUNICIPAL CODE.

The City Council of the City of Kirkland do ordain as follows:

Section 1. Kirkland Municipal Code Section 27.08.150 is amended to read as follows:

## 27.08.150 Fee schedule.

(a) School Impact Fee Schedule. School impact fees shall be set as set forth below:

| Type of Land<br>Use  | Impact Fee                          | Per Unit      |
|--|-------------------------------------|---------------|
| Single-Family<br>Dwelling<br>(detached unit)                       | <del>\$15,070</del> <u>\$18,997</u> | Dwelling Unit |
| Multifamily Dwelling (attached, stacked, and assisted living unit) | \$ <del>2,701</del> <u>\$3,510</u>  | Dwelling Unit |

- The city shall collect an administrative fee of sixty-five dollars per filing per residential permit in order to cover the administrative cost of collecting, processing, and handling the impact fees described in this chapter.
- Section 2. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.
- Section 3. This ordinance shall be in force and effect January 1, 2022, after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017, Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council.
