AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO WATER/SEWER SYSTEM CUSTOMER RATES, PROVIDING FOR AN INCREASE IN THE WATER CONSUMPTION CHARGE AND AMENDING CHAPTER 15.24 OF THE KIRKLAND MUNICIPAL CODE.

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. Table 15.24.020 of Section 15.24.020 of the Kirkland Municipal Code, as last amended by Ordinance 3295, which establishes the monthly water charge required to be paid to the City by customers of the Kirkland Water System is further amended to read as follows:

Section 2. Table 15.24.070 of Section 15.24.070 of the Kirkland Municipal Code, as last amended by Ordinance 3295, which establishes the monthly sewer charge required to be paid to the City by customers of the Kirkland Sewer Systems is further amended to read as follows:

a. Single-family residential	\$21.25
b. Multifamily residential	
(1) Basic charge	\$2.50 per residential unit

(2) Water consumption charge	\$2.55 per 100 cubic feet of water consumed

(1) Water consumption charge \$2.65 per 100 cubic feet of water consumed

(2) Minimum charge \$21.25

Section 3. Effective date for new rate: The monthly service and consumption rate for water customers established in this ordinance shall go into effect and become the rate to be charged as of February 1, 1992 provided, however, that the water consumption charge for water customers billed on the City of Kirkland billing cycles number 2, number 4, and number 5 shall go into effect March 1, 1992.

Section 4. This Ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017 Kirkland Municipal Code in summary form attached to the original of this Ordinance and by this reference approved by the City Council, as required by law.
