## **ORDINANCE O-4775**

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING THE AMOUNT OF PROPERTY TAXES TO BE LEVIED FOR THE YEAR 2022, THE SECOND YEAR OF THE CITY OF KIRKLAND'S 2021-2022 FISCAL BIENNIUM, AND REPEALING ORDINANCE O-4772.

WHEREAS, the City Council held a public hearing on November 16, 2021, to consider the 2022 property tax levy for the City of Kirkland Biennial Budget; and

WHEREAS, the City Council and the City Manager have considered the anticipated financial requirements of the City of Kirkland for the fiscal year 2022; and

WHEREAS, pursuant to RCW 35A.33.135, the City Council is required to determine and fix by ordinance the amount to be raised by ad valorem taxes; and

WHEREAS, on November 16, 2021, the City Council passed Ordinance O-4772, which was the preliminary property tax levy for fiscal year 2022; and

WHEREAS, the City Council wishes to repeal the preliminary property tax levy and pass the final tax levy based upon the most recent property tax levy data provided by King County; and

WHEREAS, RCW 84.55.120 requires that the increase in the levy over the prior year be stated both as to the dollar increase and percentage change.

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

<u>Section 1</u>. Ordinance O-4772 passed November 16, 2021 is hereby repealed.

Section 2. The regular property tax levy for the year 2022 is hereby fixed and established in the amount of \$40,760,345. This property tax levy represents a dollar increase of \$394,218 and a percentage increase of one percent from the previous year, excluding the addition of new construction, improvements to property, any increase in state-assessed property, and administrative refunds as shown below:

Section 3. There is hereby levied for 2022 upon all property, both real and personal, within the city of Kirkland, Washington, and within the area subject to tax levies for the principal and interest of all general obligation bond issues, which excludes the area annexed by the City in 2011, a total voted property tax of \$267,715 on the total of assessed valuation for such property.

<u>Section 4</u>. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017, Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council.

## PUBLICATION SUMMARY OF ORDINANCE NO. 0-4775

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING THE AMOUNT OF PROPERTY TAXES TO BE LEVIED FOR THE YEAR 2022, THE SECOND YEAR OF THE CITY OF KIRKLAND'S 2021-2022 FISCAL BIENNIUM, AND REPEALING ORDINANCE O-4772.

<u>SECTION 1</u>. Repeals Ordinance O-4772.

<u>SECTION 2</u>. Fixes and establishes the regular property tax levy for the fiscal year 2022.

SECTION 3. Levies a voted property tax for fiscal year 2022.

SECTION 4. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.
