ORDINANCE 0-3324

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO WATER CUSTOMER CONSUMPTION RATES, IMPOSING AN EMERGENCY SURCHARGE ON SAID RATES, AND TEMPORARILY SUBSTITUTING THE APPENDED TABLE FOR TABLE 15.24.020 OF SECTION 15.24.020 OF THE KIRKLAND MUNICIPAL CODE.

Whereas, the Seattle Water Department has advised area water purveyors, including the Rose Hill Water District, that extraordinary conditions created by the water shortage have resulted in the Seattle Water Department incurring emergency expenditures to maintain its water supply and that in order to pay for the additional expenditures, it has become necessary to impose an emergency surcharge on the purveyors, and

Whereas, the City of Kirkland purchases its water from the Rose Hill Water District and the District has passed on to the City a portion of the surcharge, and

Whereas, it is therefore necessary for the City to impose a temporary water consumption surcharge of four (4) months' duration on each customer of the City's water system, now, therefore,

Be it ordained by the City Council of the City of Kirkland as follows:

Section 1. A temporary surcharge on the water consumption charges paid by single-family residential, multi-family residential, and all other customers, including commercial, shall be imposed for water billings issued during September, October, November and December, 1992. For those billings, the Table appended hereto as Attachment "A" shall be in effect and, as to those billings, the use of Table 15.24.020 of Section 15.24.020 of the Kirkland Municipal Code, as last amended by Ordinance 3302, is hereby suspended.

Section 2. Beginning January 1, 1993, for water billings issued on or after that date, Table 15.24.020 of KMC Section 15.24.020, as last amended by Ordinance 3302, shall resume in effect unless and until further amended.

Section 3. This Ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
