Section 3. Effective date for new rates: The monthly service and consumption rates for water and sewer customers established in this ordinance shall go into effect and become the rates to be charged as of December 1, 1992 provided, however, that the monthly consumption rates for water and sewer customers and the monthly service rates for multifamily customers billed on the City of Kirkland billing cycles number 2, number 4, and number 5 shall go into effect January 1, 1993.

Section 4. This Ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Kirkland Municipal Code Section 1.08.017 in summary form attached to the original of this Ordinance and by this reference

approved by the City Council, as required by law.
