

ORDINANCE O-4798

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING KIRKLAND MUNICIPAL CODE TITLE 2 RELATED TO ITS COMMUNITY MUNICIPAL CORPORATION, PROVIDING FOR THE END OF ITS TERM OF EXISTENCE, AND MAKING NECESSARY CODE CHANGES PURSUANT TO HOUSE BILL 1769, CHAPTER 26, LAWS OF 2022.

1 WHEREAS, House Bill 1769, Chapter 26, Laws of 2022,
2 ends to the term of existence of any community municipal
3 corporation in the state of Washington no later than July 9, 2022,
4 while also providing for the amendment and repeal of various
5 statutory provisions related to community municipal corporations;
6 and

8 WHEREAS, the City of Kirkland includes a community
9 municipal corporation known as the "Houghton community
10 municipal corporation" embodied in various chapters in Title 2 of
11 the Kirkland Municipal Code (KMC); and
12

13 WHEREAS, it is therefore necessary to provide for the
14 amendment and repeal of Title 2 related to the Houghton
15 community municipal corporation effective July 9, 2022; and

17 WHEREAS, the City Council wishes to express its
18 appreciation to the current and former members of the Houghton
19 Community Council, who have served their community with
20 distinction.

22 NOW, THEREFORE, the City Council of the City of Kirkland
23 do ordain as follows:
24

25 Section 1. A new Chapter 2.01 of the Kirkland Municipal
26 Code is created to read as follows:
27

28 **Chapter 2.01 END OF TERM OF EXISTENCE; CODE**
29 **REFERENCES TO PROCESSES AND PROCEDURES NULL**
30 **AND VOID; CONTINUED USE OF HOUGHTON COMMUNITY**
31 **MUNICIPAL CORPORATION ZONING MAP DESIGNATION.**

33 **2.01.010 Term of existence.**
34 Pursuant to RCW 35.14.060, the term of existence of the
35 Houghton community municipal corporation is ended.
36

37 **2.01.020 Processes and procedures null and void.**
38 References to processes and procedures related to the Houghton
39 community municipal corporation in the municipal code are null
40 and void effective July 9, 2022, and until such time as such
41 provisions have been specifically repealed.

42 **2.01.030 Geographic boundaries and map designation.**
43 References in the municipal code related to the Houghton
44 community municipal corporation that pertain to land use and
45 other regulations that apply within a specific geographic area shall
46 refer to the geographic boundaries designated on the official
47 Kirkland Zoning Map as the "Houghton Community Municipal
48 Corporation Area."

50 Section 2. Kirkland Municipal Code Chapter 2.04 is hereby
51 repealed.

53 Section 3. Kirkland Municipal Code Chapter 2.08 is hereby
54 repealed.

56 Section 4. Kirkland Municipal Code Chapter 2.12 is hereby
57 repealed.

59 Section 5. Kirkland Municipal Code Chapter 2.16 is hereby
60 repealed.

62 Section 6. If any provision of this ordinance or its
63 application to any person or circumstance is held invalid, the
64 remainder of the ordinance or the application of the provision to
65 other persons or circumstances is not affected.

67 Section 7. Following passage by the Kirkland City Council
68 and publication, as required by law, this ordinance shall be
69 effective as of July 9, 2022.
