

ORDINANCE NO. 3584

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO SOLID WASTE MANAGEMENT ESTABLISHING RATES FOR COLLECTION AND AMENDING SECTION 16.12.030 OF THE KIRKLAND MUNICIPAL CODE.

BE IT ORDAINED by the City Council of the City of Kirkland as follows:

Section 1. Section 16.12.030 is hereby amended to read as follows:

16.12.030 Collection rate.

The rates to be charged for solid waste collection service in the city shall be as follows:

- (4) Wherever detachable containers are used having a capacity for which a rate has not been established, the Director of ~~Administration and Finance~~ Public Works is authorized to establish a rate for such container, which shall be consistent with the ratio of the container capacity to rate charged for the rate herein established.
- (5) In addition to the collection rates established in subsections (1), (2), and (3) above, there shall be included a County Board of Health hazardous waste charge as follows:
- (i) For each single-family residential customer the amount of sixty cents per month;
  - (ii) For each multifamily and nonresidential (commercial) customer the sum of six dollars and seventy seven cents per month.

Section 2. Effective date for new rates: The monthly rates established in this ordinance shall go into effect and become the rates to be charged as of July 1, 1997.


Section 3. This Ordinance shall be in full force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
