ORDINANCE 0-4839

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO CITY COUNCIL MEETINGS AND AMENDING KIRKLAND MUNICIPAL CODE SECTION 3.10.010.

WHEREAS, Kirkland Municipal Code (KMC) Section 3.10.010 provides that the City Council shall meet regularly for the conduct of official business and the taking of action thereon on the first and third Tuesdays of each month, provided the Council may cancel or reschedule any meeting provided it meets at least once a month; and

WHEREAS, it has been the practice of the Council to meet just one time in the month of August, on the first Wednesday of that month, in order to account for vacations during the month and to accommodate National Night Out, which is held on the first Tuesday each August; and

WHEREAS, it has been the practice of the Council to meet on the first Wednesday of each November when the first Tuesday of that month is a general election day; and

WHEREAS, it has been the practice of the Council to meet just one time in the month of December, on the second Tuesday of that month, in order to account for holidays while also giving the Council the opportunity to complete year-end budget related processes; and

WHEREAS, given the present language of KMC 3.10.010, it has been necessary for the Council to annually approve, generally through its consent calendar, the cancelation or rescheduling of the meetings referenced above; and

WHEREAS, the Council now wishes to formalize its meeting schedule practices by amending the municipal code to conform to them, while preserving the ability of the Council to add, cancel, or reschedule meetings.

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

<u>Section 1</u>. Kirkland Municipal Code Section 3.10.010 is amended to read as follows:

3.10.010 Meetings--Generally

The city council shall meet regularly for the conduct of official business and the taking of action thereon on the first and third Tuesdays of each calendar month, commencing at seven-thirty p.m.; provided, however, that the council shall meet on the first Wednesday of November in any year in which the first Tuesday of that month is a general election day; and provided that the council shall meet one time only in August on the first Wednesday of that month and one time only in December on the second Tuesday of that month; and provided further

Agendas for regularly scheduled meetings shall be available online 48 at the city website no later than twenty-four hours in advance of the 49 published start time of the regular meeting. Notice of a public hearing 50 shall be by inclusion of the hearing in the agenda unless publication of 51 52 notice of hearing is specifically required. Section 2. This ordinance shall be in force and effect five days 53 54 from and after its passage by the Kirkland City Council and publication, as required by law. 55
