## ORDINANCE NO. 3624

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO LAND USE, APPROVAL OF A PRELIMINARY AND FINAL PUD AS APPLIED FOR BY HERITAGE CREEK ASSOCIATES, L.P., IN DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT FILE NO. IIB-89-118 AND SETTING FORTH CONDITIONS OF SAID APPROVAL.

WHEREAS, the Department of Planning and Community Development has received an application, pursuant to Process IIB, for a Preliminary and Final Planned Unit Development (PUD) filed by Heritage Creek Associates, L.P., as Department of Planning and Community Development File No. IIB-89-118 to construct an assisted living facility within a PR 3.6 zone; and

WHEREAS, pursuant to the State Environmental Policy Act, RCW 43.21C, and the Administrative Guideline and local ordinance adopted to implement it, an environmental checklist was submitted to the City of Kirkland, reviewed by the responsible official of the City of Kirkland, and a negative determination reached and subsequent addenda were issued; and

WHEREAS, said environmental checklist, determination, and addenda have been available and accompanied the application through the entire review process; and

WHEREAS, the application was submitted to the Kirkland Hearing Examiner who held hearing thereon at his regular meeting of June 15, 1996; and

WHEREAS, the Kirkland Hearing Examiner after his public hearing and consideration of the recommendations of the Department of Planning and Community Development did adopt certain Findings, Conclusions and Recommendations and did recommend approval of the Process IIB Permit subject to the specific conditions set forth in said recommendations; and

WHEREAS, the City Council, in regular meeting, did consider the environmental documents received from the responsible official, together with the recommendation of the Hearing Examiner, as well as timely filed challenges of said recommendations; and

WHEREAS, subsequently the Applicant made revisions to its application; and

WHEREAS, the City Council at its regular meeting of February 17, 1998, did hold a public hearing to consider a revised PUD application and recommendations of the Department of Planning and Community Development; and WHEREAS, the Kirkland Zoning Ordinance requires approval of this application for PUD to be made by ordinance.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Kirkland as follows:

<u>Section 1.</u> The Findings, Conclusions, and Recommendations of the Kirkland Hearing Examiner as filed in the Department of Planning and Community Development File No. IIB-89-118, with amendments recommended by the Department of Planning and Community Development in its memorandum dated February 12, 1998, are adopted by the Kirkland City Council as though fully set forth herein.

<u>Section 2.</u> Nothing in this ordinance shall be construed as excusing the applicant from compliance with any federal, state or local statutes, ordinances or regulations applicable to this project, other than expressly set forth herein.

<u>Section 3.</u> Failure on the part of the holder of the permit to initially meet or maintain strict compliance with the standards and conditions to which the Process IIB/III Permit is subject shall be grounds for revocation in accordance with Ordinance No. 2740, as amended, the Kirkland Zoning Ordinance.

<u>Section 4.</u> This ordinance shall be in full force and effect five (5) days from and after its passage by the Kirkland City Council and publication, pursuant to Section 1.09.010.

<u>Section 5</u> A complete copy of this ordinance, including Findings, Conclusions and Recommendations adopted by reference, shall be certified by the City Clerk, who shall then forward the certified copy to the King County Department of Assessments.

<u>Section 6.</u> A certified copy of this ordinance, together with the Findings, Conclusions, and Recommendations herein adopted shall be attached to and become a part of the Process IIB/III Permit or evidence thereof delivered to the permittee.

<u>Section 7.</u> Certified or conformed copies of this ordinance shall be delivered to the following:

- (a) Department of Planning and Community Development of the City of Kirkland
- (b) Fire and Building Departments of the City of Kirkland
- (c) Public Works Department of the City of Kirkland
- (d) The City Clerk for the City of Kirkland.
