

ORDINANCE 3652

AN ORDINANCE OF THE CITY OF KIRKLAND ESTABLISHING PRICES TO BE CHARGED FOR BURIAL LOTS AND CREMATED REMAINS SITES IN THE KIRKLAND CEMETERY AND REPEALING AND REENACTING SECTION 3.92.020 OF THE KIRKLAND MUNICIPAL CODE.

The City Council of the City of Kirkland do ordain as follows:

Section 1. Section 3.92.020 of the Kirkland Municipal Code enacted by Section 2 of Ordinance 2590 is hereby repealed and reenacted to read as follows:

~~3.92.020 Lot prices.~~ Prices for burial lots and cremated remains sites.

~~The prices for lots in the Kirkland Cemetery are established as follows:~~

- ~~(1) Sites for cremated remains or infant graves: one hundred dollars/one hundred fifty dollars;~~
- ~~(2) Lots located in the Everett Memorial Section (most recently platted area): two hundred seventy five dollars;~~
- ~~(3) All other lots or sites: three hundred fifty dollars. (Ord. 2590 § 22, 1997; Ord. 2590 § 1, 1981)~~

I. Prices for burial lots in the Kirkland Cemetery are established as follows:

- (a) Historic Section:
  - Single Depth - Non Pre-Set ..... \$1200.00
  - Infant Plots..... \$ 300.00
  - Partial Plot ..... \$ 500.00
- (b) Non-Historic Section:
  - Single Depth - Pre-Set ..... \$1000.00
  - Double Depth - Pre-Set ..... \$1400.00
  - Urn Garden Plots ..... \$ 700.00

II. Prices for Cremated Remains Sites (Niche Walls) in the Kirkland Cemetery are established as follows:

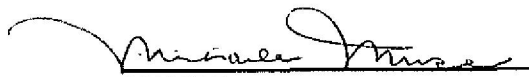
- (a) Historic Section - Niche Walk Wall/Flag Plaza Niches:
  - Level 1 ..... \$1140.00
  - Level 2 ..... \$1300.00
  - Level 3 ..... \$1300.00
  - Level 4 ..... \$1560.00

(b) Non-Historic Section - Entry Wall Niches

Level 1 .....	\$ 950.00
Level 2 .....	\$1090.00
Level 3 .....	\$1090.00
Level 4 .....	\$1265.00
Level 5 .....	\$1265.00
Level 6 .....	\$1090.00

Section 2. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law. Passed by majority vote of the Kirkland City Council in regular, open meeting this 1st day of September, 1998.
