AN ORDINANCE OF THE CITY OF KIRKLAND, RELATING TO SENSITIVE AREAS, EXTENDING TO MARCH 31, 2001 INTERIM REGULATIONS FOR SENSITIVE AREAS AS ADOPTED BY ORDINANCE NO. 3658; AND AMENDING SECTION 2 OF ORDINANCE NO. 3742.

Section 1. Provides findings of fact for the ordinance.

<u>Section 2</u>. Further amends Section 2 of Ordinance No. 3658, as last amended by Section 2 of Ordinance No. 3742, to extend the interim ordinance to March 31, 2001.

<u>Section 3.</u> Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.

AN ORDINANCE OF THE CITY OF KIRKLAND, RELATING TO SENSITIVE AREAS, EXTENDING TO MARCH 31, 2001 INTERIM REGULATIONS FOR SENSITIVE AREAS AS ADOPTED BY ORDINANCE NO. 3658; AND AMENDING SECTION 2 OF ORDINANCE NO. 3742.

WHEREAS, the City Council has the authority to adopt interim regulations pursuant to RCW 35A.63.220 and 36.70A.390; and

WHEREAS, by Ordinance No. 3658, passed on October 20, 1998, the City Council adopted interim regulations that protect the particular functions and values of each drainage basin (sensitive areas); and

WHEREAS, by Ordinance No. 3684, passed on April 6, 1999, the City Council renewed Ordinance No. 3658 until September 30, 1999; and

WHEREAS, by Ordinance No. 3706, passed on September 7, 1999, the City Council renewed Ordinance No. 3658 until March 31, 2000; and

WHEREAS, by Ordinance No. 3742, passed on March 21, 2000, the City Council renewed Ordinance No. 3658 until September 30, 2000; and

WHEREAS, on September 19, 2000, the City Council held a public hearing on renewal of Ordinance No. 3658 until March 31, 2001; and

WHEREAS, the City Council desires to renew Ordinance No. 3658 until March 31, 2001;

NOW, THEREFORE, the City Council of the City of Kirkland, Washington, do ordain as follows:

<u>Section 1.</u> <u>Findings of Fact</u>. The City Council finds that renewal or extension of Ordinance No. 3658 until March 31, 2001 is necessary in order to verify the effectiveness of the requirements of Ordinance No. 3658 and to complete permanent regulations for sensitive areas.

Section 2. Amendment. Section 2 of Ordinance No. 3658, as last amended by Section 2 of Ordinance No. 3742, is further amended as follows:

This ordinance shall be effective until March 31, 2001. This ordinance may be renewed if a subsequent public hearing is held and findings of fact are made prior to each renewal.

<u>Section 3.</u> <u>Effective Date</u>. This ordinance shall be in effect five days from and after its passage by the Kirkland City Council and publication, pursuant to Section 1.088.017 Kirkland Municipal Code, in the summary form attached to the original of this ordinance, and by this reference approved by the City Council, as required by law.
