# AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO SOLID WASTE MANAGEMENT AND AMENDING SECTION 16.12.030 OF THE KIRKLAND MUNICIPAL CODE.

The City Council of the City of Kirkland do ordain as follows:

Section I. Section 16.12.030 is hereby amended to read as follows:

- (4) Wherever detachable containers are used having a capacity for which a rate has not been established, the Director of Public Works is authorized to establish a rate for such container, which shall be consistent with the ratio of the container capacity to rate charged for the rate herein established.
- (5) In addition to the collection rates established in subsections (1),
  (2), and (3) above, there shall be included a County Board of Health hazardous waste charge as follows:
- (A) For each single-family residential customer the amount of sixty cents per month;

(B) For each multifamily and nonresidential (commercial) customer the sum of six dollars and seventy-seven cents per month.

Section 2. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.107, Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council.
