ORDINANCE _ 3788 _

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO WATER SYSTEM CUSTOMER RATES, PROVIDING FOR CHANGES IN SAID RATES AND REPEALING AND REENACTING SECTION 15.24.020 OF THE KIRKLAND MUNICIPAL CODE.

The City Council of the City of Kirkland do ordain as follows:

<u>Section 1</u>. Kirkland Municipal Code Section 15.24.020, including Table 15.24.020, as last amended by Ordinance 3729, is hereby repealed.

<u>Section 2</u>. There is hereby created a new section of the Kirkland Municipal Code to be designated KMC 15.24.020, entitled "Monthly water rates" and to read as follows:

15.24.020 Monthly water rates.

The monthly water charge required to be paid to the City by customers of the water system is established in Table 15.24.020.

<u>Section 3</u>. Effective date for new rates: The monthly service and consumption rates for water customers established in this ordinance shall go into effect and become the rates to be charged as of May 1, 2001 provided, however, that the monthly consumption rates for water customers billed on the City of Kirkland billing cycles number 3, number 6, and number 8 shall go into effect June 1, 2001.

<u>Section 4</u>. The water rates set forth in KMC 15.24.020, which is repealed by this ordinance, shall remain in force and effect until the rates set forth in this ordinance go into effect.

<u>Section 5</u>. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance, or the application of the provision to other persons or circumstances is not affected.

<u>Section 6</u>. This Ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
